## II. Annotations

### 1. Adoption of the agenda and other organizational matters

At its organizational session for 1999, the Council approved the provisional agenda for its substantive session (decision 1999/201).

In accordance with rule 12 of the rules of procedure of the Economic and Social Council (E/5715/Rev.2), should any proposals be submitted for the inclusion of supplementary items in the agenda, they will be circulated as soon as they are received, and a supplementary list of items will be issued as an addendum to the provisional agenda.

In accordance with General Assembly resolution 50/227, annex I, the Council will have before it a note by the Secretary-General on proposed themes for the high-level and coordination segments of the substantive session of 2000 of the Council.

### A. High-level segment

#### 2. The role of employment and work in poverty eradication: the empowerment and advancement of women

At its substantive session of 1998, the Economic and Social Council decided that the high-level segment of the substantive session of 1999 of the Council would be devoted to the consideration of the following theme: "The role of employment and work in poverty eradication: the empowerment and advancement of women" (decision 1998/298).

By selecting this theme, the Council has met the request made by the General Assembly and the Fourth World Conference on Women that the Council devote one high-level segment to the advancement of women and the implementation of the Beijing Platform for Action (General Assembly resolution 52/100).

The theme is also highly relevant to the one-day policy dialogue with the heads of financial and trade institutions, and should therefore be a main focus of that dialogue in 1999.

The Council will have before it, at its high-level segment, the report of the Secretary-General on the subject.

The Council will also have before it the *World Economic and Social Survey, 1999*, prepared pursuant to General Assembly resolutions 118 (II) and 52/180 and Council resolution 1983/50. Part one of the *Survey* assesses the current global economic situation, including a forecast of output, international trade and other key economic variables in 1999 in the main regions of the world. In part two, the *Survey* examines aspects of financing for development. Drawing on the experiences of developed, developing and transition economies, and in the light of the increase in international financial activities, it considers questions of the effectiveness, equity and stability of different institutions and market arrangements for financial intermediation, including issues of management, the roles of the public and private sectors, and public oversight. The *Survey* also includes an extensive statistical annex of economic, trade and financial indicators.

The Council will have before it for information the executive summary of the *World Survey on the Role of Women in Development*.

**B. Operational activities of the United Nations for international development cooperation segment**

**3. Operational activities of the United Nations for international development cooperation**

**(a) Poverty eradication and capacity-building**

In accordance with General Assembly resolution 53/192, paragraph 62, and Council decision 1998/299, the Council will consider the issue of poverty eradication and capacity-building at the high-level meeting of the operational activities segment.

**(b) Follow-up to policy recommendations of the General Assembly**

In accordance with Assembly resolution 53/192, paragraph 61, the Council will examine the operational activities for development of the United Nations system in order to evaluate the implementation of the triennial policy review of those activities, with a view to ensuring its full implementation.

In paragraph 60 of the resolution, the Assembly requested the Secretary-General, after consultation with the funds, programmes and specialized agencies of the United Nations system, to present a progress report to the Council at its substantive session of 1999 on an appropriate management process, containing clear guidelines, targets, benchmarks and time-frames for the full implementation of the resolution.

In paragraph 63 of the resolution, the Assembly requested the Secretary-General to report annually to the Council on the United Nations Development Assistance Framework.

In accordance with paragraph 11 of annex I to General Assembly resolution 50/227, paragraph 16 of its resolution 53/192 and paragraph 3 of Council resolution 1998/27, the Council will also consider the overall financial picture of the United Nations funds and programmes, including the availability of resources, the priorities and programmes agreed upon in the funds and programmes and the adopted targets, and will provide further guidance on priorities and make recommendations thereon to the Assembly and to the funds and programmes.

By its resolution 1998/27, paragraph 4, the Council invited the Secretary-General to arrange for the submission by the executive heads of the United Nations funds and programmes, in consultation with the United Nations Development Group, to the Council at its annual substantive session, of a concise consolidated list of issues that were central to the improved coordination of operational activities and on which the funds and programmes sought

consideration by and guidance from the Council, particularly in regard to the triennial policy review, and to include in the list recommendations whenever possible.

(c) **Reports of the Executive Boards of the United Nations Development Programme/  
United Nations Population Fund, the United Nations Children's Fund and the  
World Food Programme**

In its resolution 48/162, annex I, paragraph 29, the Assembly decided, in order to ensure an effective and efficient interaction between the Assembly, the Council and the individual Executive Boards, that each Board would submit an annual report on its programmes and activities to the Council at its substantive session. In its resolution 1994/33, the Council requested the United Nations funds and programmes, through their Executive Boards, to include in their annual reports to the Council (a) a section outlining measures taken in the implementation of the provisions of the triennial policy review of operational activities and (b) a section on the activities and measures undertaken within the designated theme for the high-level meeting of the operational activities segment.

At its fifty-third session, the General Assembly invited the Executive Boards of the United Nations funds and programmes to ensure that the heads of the funds and programmes included in their annual reports to the Council a thorough analysis of problems encountered and lessons learned, with emphasis on issues arising from the implementation of the Secretary-General's reform programme, the triennial policy review and the follow-up to international conferences, so as to allow the Council to fulfil its coordinating role (resolution 53/192, para. 59).

The Council will also have before it information from the Executive Director of the World Food Programme regarding proposed amendments to the General Regulations of the Programme.

(d) **Economic and technical cooperation among developing countries**

The High-level Committee on the Review of Technical Cooperation among Developing Countries is entrusted with the overall intergovernmental review of technical cooperation among developing countries within the United Nations system. It reports to the General Assembly through the Governing Council of the United Nations Development Programme and the Economic and Social Council in accordance with the Buenos Aires Plan of Action

for Promoting and Implementing Technical Cooperation among Developing Countries (General Assembly resolution 33/134). The Council will have before it the report of the Committee on its eleventh session (Headquarters, 7–11 June 1999).

### **C. Coordination segment**

#### **4. Coordination of the policies and activities of the specialized agencies and other bodies of the United Nations system related to the following theme: Development of Africa: implementation and coordinated follow-up by the United Nations system of initiatives on African development**

In accordance with Council decision 1998/298, the coordination segment will be devoted to the consideration of the following cross-sectoral theme: “Development of Africa: implementation and coordinated follow-up by the United Nations system of initiatives on African development”.

The Council will have before it the report of the Secretary-General on the subject.

Furthermore, at its substantive session of 1998, the Council decided to undertake substantive discussions on the implementation of the relevant recommendations of the report of the Secretary-General on the causes of conflict and the promotion of durable peace and sustainable development in Africa (A/52/871–S/1998/318) at its substantive session of 1999, taking into account views expressed by Governments during the discussion of the report of the Secretary-General at the fifty-third session of the General Assembly (decision 1998/283).

In its resolution 53/92, the Assembly supported the recommendation to harmonize current international and bilateral initiatives on Africa contained in the report of the Secretary-General, and invited African countries and their partners during the coordination segment of the 1999 substantive session of the Council to identify and rank priorities in partnership, to define respective responsibilities and to agree on realistic and measurable targets in priority areas.

### **D. Humanitarian affairs segment**

#### **5. Special economic, humanitarian and disaster relief assistance**

At its organizational session for 1999, the Economic and Social Council decided that the theme of the humanitarian affairs segment should be “*International cooperation and coordinated responses to the humanitarian emergencies, in particular, in the transition from relief to rehabilitation, reconstruction and development*” (decision 1999/208).

At its forty-sixth session, the Assembly requested the Emergency Relief Coordinator to prepare an annual report for the Secretary-General on the *coordination of humanitarian emergency assistance of the United Nations*, including information on the central emergency

revolving fund, to be submitted to the Assembly through the Council (resolution 46/182, annex, para. 35 (I)).

At its fifty-third session, the Assembly welcomed the first humanitarian affairs segment of the Council, held during its substantive session of 1998 and agreed conclusions 1998/1, adopted at that session (see A/53/3, chap. VII), and requested the Secretary-General to report to it, through the 1999 substantive session of the Council, on the strengthening of the coordination of emergency humanitarian assistance of the United Nations, including the implementation of and follow-up to Council agreed conclusions 1998/1. It also invited the Council to consider ways to enhance further the humanitarian affairs segment of future sessions of the Council, as outlined in agreed conclusions 1998/1 (resolution 53/88).

The Assembly also requested the Secretary-General to report to it, through the Council at the humanitarian affairs segment of its 1999 substantive session, on the collaborative effort between the Secretary-General, the international financial institutions and bodies and agencies of the United Nations system and on the *progress made with the relief, rehabilitation and reconstruction efforts of Antigua and Barbuda, Cuba, the Dominican Republic, Haiti and Saint Kitts and Nevis* (resolution 53/1 B) and on the *progress made with the relief, rehabilitation and reconstruction efforts of Belize, Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua and Panama* (resolution 53/1 C).

Also at its fifty-third session, the Assembly requested the Secretary-General to report to it at its fifty-fourth session, through the Council at the humanitarian affairs segment of its substantive session, on the progress made with regard to *economic assistance to Djibouti* and the implementation of the resolution (resolution 53/1 J).

In accordance with Council resolution 1983/46, the Secretary-General appraises the Council annually on the status of the *assistance to the drought-stricken areas of Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Uganda*.

## **E. General segment**

### **6. Integrated and coordinated implementation of and follow-up to major United Nations conferences and summits**

In accordance with General Assembly resolution 45/264, the Council will have before it the report of the Secretary-General on the implementation of the agreed conclusions of the 1998 coordination segment of the Council on coordinated follow-up to and implementation of the Vienna Declaration and Programme of Action.



At its substantive session of 1997, the Council requested the Secretary-General, in cooperation with organizations of the United Nations system, to submit to it an annual report on the progress achieved by the United Nations system at the intergovernmental, inter-agency and country levels, with specific recommendations on ways to enhance the integrated and coordinated implementation and follow-up of the major United Nations conferences and summits (resolution 1997/61). In its resolution 1998/44 on the same topic, the Council invited the Secretary-General to prepare a progress report on the implementation of the resolution for consideration by the Council in 1999. In the same resolution, the Council agreed to consider conducting in 2000, as a possible contribution to the Millennium Assembly, a review by the Council of progress made within the United Nations system in the promotion of integrated and coordinated implementation and follow-up to major United Nations conferences and summits in the economic, social and related fields, and requested the Secretary-General to submit to it at its substantive session of 1999 a report on possible modalities of such a review.

The report of the Committee for Programme and Coordination on its thirty-ninth session (Headquarters, June–July 1999) will include the Committee's views on its consideration of the report of the Administrative Committee on Coordination.

#### **(b) Proposed programme budget for the biennium 2000–2001**

In accordance with rule 31 of the rules of procedure of the Council, the Secretary-General will circulate the sections of the proposed programme budget for the biennium 2000–2001 covering activities in the economic, social and human rights fields. The Council will consider the relevant sections of the proposed programme budget in the light of the recommendations of the Committee for Programme and Coordination on the matter, with a view to submitting its own recommendations thereon to the General Assembly (Council resolution 1988/77).

**(c) Joint and Co-sponsored United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS)**

At its substantive session of 1997, the Council requested co-sponsoring organizations and the Joint and Co-sponsored United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS) to disseminate clear guidance to country-level staff on the role and functions of the United Nations theme groups on HIV/AIDS and their respective roles in providing technical assistance, and to report back to their respective governing bodies and to the Programme Coordinating Board on measures undertaken in this respect; requested the United Nations funds and programmes and invited the specialized agencies to ensure effective coordination of HIV/AIDS-related activities in the context of the resident coordinator system; and requested the Secretary-General to transmit to the Council, at its substantive session of 1999, a comprehensive report prepared by the Executive Director of the Programme in collaboration with other relevant organizations of the United Nations system (resolution 1997/52).

**(d) International cooperation in the field of informatics**

At its substantive session of 1998, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year for the due fulfilment of the provisions of the Council resolutions on the item and for facilitating the successful implementation of the initiatives being taken by the Secretary-General with regard to use of information technology, and also requested the Secretary-General to report to it at its substantive session of 1999 on the follow-up action taken on the resolution, including the findings of the Working Group (resolution 1998/29).

At its fifty-first session, the General Assembly requested the Secretary-General to report, through the Committee on Conferences, to each subsidiary organ of the Assembly and the Council on the cost of the conference services it utilized in the year concluded in order to enable those organs to plan more effectively (Assembly resolution 51/211 C).

#### **8. Implementation of General Assembly resolutions 50/227 and 52/12 B**

At its substantive session of 1998, the Council decided to continue its deliberations on pending issues pursuant to the mandates given to it, as contained in General Assembly resolutions 50/227 and 52/12 B (resolution 1998/46).

At its organizational session for 1999, the Council looked forward to the annual progress report of the Secretary-General on the further implementation of Assembly resolutions 50/227 and 52/12 B and Council resolution 1998/46, to be submitted to it at its substantive session of 1999 (resolution 1999/1).

In accordance with Assembly resolution 50/227, annex I, and Council resolutions 1998/46, annex II, and 1999/1, the Council will also have before it the report of the Secretary-General on the work of, and examining the linkages between, the functional commissions.

In resolution 1999/1, the Council requested the Secretary-General to prepare a progress report on cooperation between the United Nations and the Bretton Woods institutions at all levels. The joint United Nations/Bretton Woods institutions meeting will be held at Headquarters on 29 April 1999.

*Assistance to the Palestinian people.* At its sixty-third session, in 1977, the Council requested the Secretary-General to submit to it annual reports on the question of assistance to the Palestinian people (resolution 2100 (LXIII)).

At its fifty-third session, the General Assembly requested the Secretary-General to submit a report to it at its fifty-fourth session, through the Council, on the implementation of Assembly resolution 53/89 on the subject.

*Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples by the specialized agencies and the international institutions associated with the United Nations.* At its substantive session of 1998, the Council requested its President to continue to maintain close contact with the Chairman of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, and to report thereon to the Council; it requested the Secretary-General to follow the implementation of the resolution and to report thereon to the Council at its substantive session of 1999 (resolution 1998/38). At its fifty-third

session, the General Assembly requested the Council to continue to consider, in consultation with the Special Committee, appropriate measures for coordination of the policies and activities of the specialized agencies and other organizations of the United Nations system in implementing the relevant resolutions of the Assembly (resolution 53/62).

### **10. Regional cooperation**

The Council will consider the report of the Secretary-General on regional cooperation and take the necessary action on the decisions and recommendations of the regional commissions contained therein.

The Council will also have before it the *summaries of the surveys of regional economic and social conditions* prepared by the regional commissions, highlighting the main problems and prospects of those regions. At its first regular session of 1979, the Council decided to discontinue the submission to it of the reports of the regional commissions (decision 1979/1). The reports are transmitted directly to all Member States. The Secretary-General, in his *annual report on regional cooperation*, in addition to reporting on the meetings of the executive secretaries, highlights developments within each region and draws the Council's attention to specific issues requiring its consideration. The report of the Secretary-General will bring to the Council's attention any decisions or recommendations of the regional commissions that statutorily require approval by the Council. A section of the report will deal with the question of *economic and social issues arising out of the Asian economic crisis: a regional perspective* (Council decision 1999/203).

At its substantive session of 1997, the Council requested the Executive Secretaries of the Economic Commission for Africa and the Economic Commission for Europe to continue to take an active part in the follow-up to the project on a *Europe-Africa permanent link through the Strait of Gibraltar* and to report to the Council at its substantive session of 1999 (resolution 1997/48).

At its substantive session of 1998, the Council requested the Secretary-General to submit to the General Assembly, at its fifty-fourth session, through the Economic and Social Council, a report on the implementation of the resolution and to continue to include, in the report of the United Nations Special Coordinator in the Occupied Territories, an update on the living conditions of the Palestinian people, in collaboration with relevant United Nations agencies (resolution 1998/32). The attention of the Council is drawn to Assembly resolution 53/196 on the subject.

**13. Economic and environmental questions**

At its organizational session for 1999, the Council requested the functional commissions that had not yet done so to implement General Assembly resolution 50/227 with regard to the provision of summaries of their resolutions or decisions for action by and/or for the attention of the Council. It also welcomed recommendations 1, 3, 4, 5 and 6 of section 1, recommendation 1 of section 2, and the recommendations contained in sections 3 to 9 of the consolidated report on the outcomes of the functional commissions of the Council in 1998 (E/1999/3), decided to transmit to the appropriate functional commissions those recommendations for their implementation, and requested the commissions to report to it at its substantive session of 1999 on the follow-up actions taken (resolution 1999/1).

### **(a) Advancement of women**

The Council will have before it the report of the *Commission on the Status of Women* on its forty-third session (New York, 1–19 March 1999). The provisional agenda for the forty-third session of the Commission was approved by the Council in its decision 1998/224.

The Council will also have before it the report of the *Board of Trustees of the International Research and Training Institute for the Advancement of Women* on its nineteenth session. The Institute functions under the authority of a Board of Trustees, which reports annually to the Council.

At its substantive session of 1998, the Council requested the Director of the Institute, in cooperation with the Board of Trustees, to present a report to the Council at its next substantive session containing, *inter alia*, a *detailed analysis of the reasons for the financial and staffing situation of the Institute* (resolution 1998/48).

In its resolution 50/203, the Assembly requested the Secretary-General to report annually to the Commission on the Status of Women and to the Assembly, through the Council, on the measures taken and the progress achieved in the implementation of the Beijing Declaration and the Platform for Action. At its fifty-second session, the Assembly decided to convene, in the year 2000, a *high-level plenary review to appraise and assess the progress achieved in the implementation of the Nairobi Forward-looking Strategies for the Advancement of Women and the Beijing Platform for Action* (resolution 52/100). At its fifty-third session, the Assembly decided that the special session of the General Assembly should be entitled “Women 2000: gender equality, development and peace for the twenty-first century” and would take place from 5 to 9 June 2000. The Commission on the Status of Women acting as the preparatory committee for the special session will report directly to the General Assembly (resolution 53/120).

At its fifty-second session, the General Assembly requested the Secretary-General to prepare, in consultation with Member States and relevant United Nations organizations, a report on the improvement of the situation of women in rural areas and to submit it, through the Council, to the General Assembly at its fifty-fourth session (resolution 52/93).

*Convention on the Elimination of All Forms of Discrimination against Women* (General Assembly resolution 34/180, annex). The Convention entered into force on 3 September 1981.

The Committee on the Elimination of Discrimination against Women was established under article 17 of the Convention for the purpose of considering the progress made in the implementation of the Convention. Under article 21 of the Convention, the Committee shall report annually on its activities to the General Assembly through the Council and may make suggestions and general recommendations based on the examination of reports and information received from the States parties to the Convention.

II).

At its fifty-third session, the General Assembly requested the Secretary-General to submit a comprehensive report on the *situation of refugees, returnees and displaced persons in Africa* to the General Assembly at its fifty-fourth session, and to present an oral report to the Economic and Social Council at its substantive session of 1999 (resolution 53/126).

(f) **Implementation of the Programme of Action for the Third Decade to Combat Racism and Racial Discrimination**

The Council will consider the report of the Secretary-General on the implementation of the Programme of Action for the Third Decade to Combat Racism and Racial Discrimination (1993–2003), as requested by the General Assembly in its resolution 48/91, paragraph 16. In that resolution, the Assembly proclaimed the Third Decade to Combat Racism and Racial Discrimination, beginning in 1993, and adopted the Programme of Action for the Decade contained in the annex to the resolution. The Assembly entrusted the Council and the Commission on Human Rights, in cooperation with the Secretary-General, with the responsibility for coordinating the programmes and evaluating the activities undertaken in connection with the Decade and requested the Secretary-General to submit each year to the Council a detailed report on all activities of United Nations bodies and the specialized agencies, analysing the information received on such activities to combat racism and racial discrimination.

At its fifty-third session, the General Assembly requested the Commission on Human Rights to present, through the Economic and Social Council, before the end of the fifty-third session of the General Assembly, a concrete proposal on the date and venue of the *World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance* (resolution 53/132, sect. II).

At its fiftieth session, the Assembly adopted the programme of activities for the Decade as contained in the annex to resolution 50/157. It also decided that the programme of activities for the Decade might be reviewed and updated throughout the Decade and that, at the mid-point of the Decade, the Economic and Social Council and the General Assembly would review the results of the activities to identify obstacles to the achievement of the goals of the Decade (resolution 50/157).

(h) **Human rights**

The Council will have before it the report of the *Commission on Human Rights* on its fifty-fifth session (Geneva, 22 March–30 April 1999). The report of the Commission is expected to include its response to the following resolutions:

- (i) General Assembly resolution 53/156, in which the Assembly decided to keep the *situation of human rights in Rwanda* under consideration at its fifty-fourth session,

in the light of additional elements provided by the Commission on Human Rights and the Economic and Social Council;

- (ii) General Assembly resolution 53/165, in which the Assembly decided to keep the *situation of human rights in Afghanistan* under consideration at its fifty-fourth session, in the light of additional elements provided by the Commission on Human Rights and the Economic and Social Council.

The Council will also have before it the general comments of the *Human Rights Committee*. The International Covenant on Civil and Political Rights (General Assembly resolution 2200 A (XXI), annex) entered into force on 23 March 1976. The complete report of the Committee is submitted to the Assembly pursuant to Council decision 1985/105.

The Council will have before it the report of the *Committee on Economic, Social and Cultural Rights* on its eighteenth and nineteenth sessions (Geneva, 27 April–15 May 1998 and 16 November–4 December 1998). The Committee on Economic, Social and Cultural Rights was entrusted by the Council, as from 1987, with overseeing the implementation of the International Covenant on Economic, Social and Cultural Rights (Council resolution 1985/17). It will be recalled that the International Covenant on Economic, Social and Cultural Rights (General Assembly resolution 2200 A (XXI), annex) entered into force on 3 January 1976. Under article 16 of the Covenant, States parties to the Covenant undertake to submit to the Secretary-General reports on the measures that they have adopted and on the progress made in achieving the observance of the rights recognized in the Covenant. The Secretary-General is required to transmit copies of the reports to the Council for its consideration.

The Council will also have before it the report of the *United Nations High Commissioner for Human Rights*. At its forty-eighth session, the General Assembly decided to create the post of United Nations High Commissioner for Human Rights; it also decided, *inter alia*, that the High Commissioner would be the United Nations official with principal responsibility for United Nations human rights activities under the direction and authority of the Secretary-General. The Assembly requested the High Commissioner to report annually on his/her activities, in accordance with his/her mandate, to the Commission on Human Rights and, through the Council, to the Assembly (resolution 48/141).
