Report of the Secretary-General

Summary

The present report has been prepared in accordance with paragraph 5 (d) of the annex to resolution 58/316. It contains the draft programme of work of the plenary for the sixty-second session of the General Assembly. The draft programmes of work of five of the six Main Committees of the Assembly, which were adopted by the Assembly during the main part of its sixty-first session, can be found in the respective decisions of the Assembly. The status of documentation will be issued as an addendum to the present report.

Introduction

1. The General Assembly, in paragraph 5 (d) of the annex to its resolution 58/316 entitled "Further measures for the revitalization of the work of the General Assembly", decided that in July of each year, the General Committee should conduct a review of the proposed programme of work for the forthcoming session of the Assembly, on the basis of a report submitted by the Secretary-General, and also submit recommendations on the matter to the Assembly at its forthcoming session. The report should include information on the status of documentation to be issued during the forthcoming session.

2. The present report has been prepared in response to that request.

3. The draft programmes of work of the Main Committees, with the exception of the Fifth Committee,¹ have been approved by the respective Committees and were adopted by the General Assembly in the following decisions: First Committee (decision 61/516 of 6 December 2006); Special Political and Decolonization Committee (Fourth Committee) (decision 61/523 of 14 December 2006); Second Committee (decision 61/544 of 20 December 2006); Third Committee (decision 61/532 of 20 December 2006); and Sixth Committee (decision 61/509 of 4 December 2006). However, since the adoption of the decisions, the draft programme of work of the Second Committee has been revised in the light of Assembly resolution 61/134 of 14 December 2006.

4. To assist the General Committee and the General Assembly in their efforts to maximize both effectiveness and efficiency, this report therefore contains only the draft programme of work of the plenary for the sixty-second session of the General Assembly, and the revised draft programme of work of the Second Committee. The details of the draft programmes of the other four Main Committees are available in the respective decisions.

5. The status of documentation will be issued as an addendum to the present report.

II. Revised draft programme of work of the Second Committee for the sixty-second session of the General Assembly

- 1. Permanent sovereignty of the Palestinian people in the Occupied Palestinian Territory, including East Jerusalem, and of the Arab population in the occupied Syrian Golan over their natural resources.
- 2. Information and communication technologies for development.
- 3. Macroeconomic policy questions:
 - (a) International trade and development;
 - (b) International financial system and development;
 - (c) External debt crisis and development.
- 4. Follow-up to and implementation of the outcome of the International Conference on Financing for Development:
