## Death and disability benefits

#### Note by the Secretary-General

1. The information contained in the annex to the present note is submitted pursuant to paragraphs 16 and 17 of General Assembly resolution 51/239 A of 17 June 1997, in which the Assembly noted that, as at 19 May 1997, a backlog of 564 death and disability claims awaited processing and requested the Secretary-General to submit to the Assembly quarterly written reports on the progress made in clearing the backlog.

2. The first quarterly report, dated 28 October 1997 (A/52/538), presented information relating to death and disability incidents occurring up to and including 30 June 1997, indicating the total number of claims from the backlog that had been received since 19 May 1997, as well as the number of claims processed as at 30 September 1997. The second quarterly report provided updated information as at 31 December 1997 (A/C.5/52/37), while the third quarterly report presented updated information as at 31 March 1998 (A/C.5/52/50). The fourth quarterly report provided updated information as at 30 June 1998 (A/C.5/53/16). The most recent update was provided in the fifth quarterly report which presented information as at 30 September 1998 (A/C.5/53/17) and Corr.1).

3. The present document constitutes the sixth quarterly report. The information presented in the attached annex indicates the total number of claims received from troop-contributing countries as at 31 December 1998, identifying the number of claims received since 19 May 1997. This information is presented by country (table A) and by peacekeeping operation (table B). A comparison of the total number of incidents of death and disability reported by peacekeeping operations as at 31 December 1998 and the related number of claims submitted to the Secretariat is presented in table C.

4. It should be recalled that, as was reflected in the fifth quarterly report, a total number of 147 claims were awaiting processing as at 30 September 1998. As at 31 December 1998, the total number of claims awaiting processing stands at 208. Of this total, 63 claims constitute part of the backlog as they were received prior to 19 May 1997. The remaining 145 claims were received in the period following 19 May 1997. A total of 104 claims were received by the Secretariat during the period 1 September through 31 December 1998, which greatly contributed to the increase in the number of unprocessed claims.
