The Working Group will have before it the 2009 joint report, which covers effects-oriented activities based on the 2009 workplan, technical documents from the programmes, and other documents and publications made available by the programmes. Lead countries will draw attention to recent activities, in particular publications and task force meetings. The Working Group is expected to take note of the progress made. It may wish to provide guidance for future activities. The ongoing review of recent results is divided up into the following pollution-specific topics:

- (a) Cross-cutting items;
- (b) Acidification and nutrient nitrogen;
- (c) Ozone;
- (d) Particulate matter, heavy metals and persistent organic pollutants.

Each topic will have contributions from the relevant workplan items and the other work carried out in all programmes. The presentations will also include issues from the technical reports of the programmes and workshops. The Working Group is expected to take note of the technical reports and the completion of workplan items. It may wish to provide guidance for future goals.

# Item 6. Review of air pollution effects

The Working Group will have before it for consideration documents describing the status report on airborne nitrogen effects, prepared in collaboration with the Task Force on Integrated Assessment Modelling and the Task Force on Reactive Nitrogen. The report on indicators and targets comprises the work carried out under three workplan items common to all programmes, including selected key monitored and modelled parameters, considerations for target-setting in 2020 and non-binding aspirational targets for the year 2050, and further quantification of policy-relevant effects indicators. The Working Group is expected to adopt the reports and to approve their submission to the Executive Body at the latter's twenty-seventh session.

## Item 7. Further development of effects-oriented activities

The Working Group will have before it for consideration documents taking into account the recent relevant decisions of the Executive Body and other subsidiary bodies of the Convention as well as available information on the air pollution policies of the European Commission. The Working Group is expected to approve the submission of the draft 2010 workplan to the Executive Body at the latter's twenty-seventh session. The Bureau has decided to propose to the

Working Group that it review the effects-oriented activities before the next session in 2010, with further details on the proposal to be made available in an informal document in the meeting room. The Working Group will also discuss possibilities for further collaboration with relevant international work.

# Item 8. Financing of effects-oriented activities

**Tentative timing:** Friday, 25 September, afternoon

The Working Group will have before it a note prepared by the secretariat detailing the financing of effects-oriented activities, summarizing the voluntary contributions received in 2008 and 2009, reviewing the use of contributions in 2009, and presenting plans for their use in 2010. The Working Group is expected to consider the note and to approve its submission to the Executive Body at the latter's twenty-seventh session.
