## Addendum

1. Pursuant to General Assembly resolutions 32/162 of 19 December 1977, 40/202 of 17 December 1985 and 45/264 of 13 May 1991, the Economic and Social Council is to elect, at its resumed organizational session for 1999, 19 members of the Commission on Human Settlements, for a four-year term beginning on 1 January 2000, to fill the vacancies created by the expiration on 31 December 1999 of the terms of the following members: Algeria, Barbados, Benin, Bulgaria, Colombia, Czech Republic, Denmark, Germany, India, Jordan, Kenya, Mexico, Norway, Philippines, Spain, Sri Lanka, Sudan, Tunisia and United Arab Emirates.
2. In accordance with paragraph 1 of section II of General Assembly resolution 32/162, the 19 members are to be elected on the following basis:

Five seats for African States;
Five seats for Asian States;
Two seats for Eastern European States;
Three seats for Latin American and Caribbean States;
Four seats for Western European and other States.
