Addendum

1. In accordance with decision 7 adopted by the Preparatory Committee at its organizational session held in May 1998, the Committee decided that its work should be open to the participation of non-governmental organizations which were accredited in accordance with Economic and Social Council resolution 1996/31 and decisions 1996/208 and 1996/315.
2. The Committee further decided that non-governmental organizations in consultative status with the Economic and Social Council and on the Roster will be invited to participate in its meetings. In addition, other non-governmental organizations that were accredited to the World Summit for Social Development or other major United Nations conferences will be invited to apply for accreditation to the Committee. The Secretary-General is requested to provide to Member States, in a timely fashion, a list of the latter non-governmental organizations for review.
3. The organizations listed in the annex represent those which were accredited to the Summit and other major United Nations conferences and are in the process of applying for consultative status with the Council. The Secretariat recommends to the Committee the accreditation of the 10 non-governmental organizations listed.
