LETTER DATED 4 SEPTEMBER 1992 FROM THE CHARGE D'AFFAIRES A.I.  
OF THE PERMANENT MISSION OF THE ISLAMIC REPUBLIC OF IRAN TO  
THE UNITED NATIONS ADDRESSED TO THE PRESIDENT OF THE SECURITY  
COUNCIL

Upon instructions from my Government, I have the honour to bring to your attention the following instances of violations by Iraq of the terms of the cease-fire between the two countries.

1. On 21 February 1992, at 1050 hours, three Iraqi forces aboard a Jeep entered a sentry post at the geographical coordinates of QA 305-816 on the map of Nahr-Anbar, west of border pillar 22/30 and after conducting observation and surveying of the area left at 1100 hours.
2. On 24 February 1992, at 0900 hours, nine Iraqi forces were observed constructing a bunker at the geographical coordinates of PB 100-720 on the map of Mehran, south of border pillar 33.
3. On 24 February 1992, at 1030 hours, an Iraqi soldier was seen deploying an automatic machine-gun at the geographical coordinates of QA 305-816 on the map of Nahr-Anbar, west of border pillar 22/30.
4. On 27 February 1992, at 1030 hours, 10 Iraqi forces were observed digging a connecting trench at the geographical coordinates of PB 100-720 on the map of Mehran, south of border pillar 33.
5. On 27 February 1992, at 1030 hours, two Iraqi forces deployed an automatic machine-gun (50 mm) on the roof of Chalaie sentry post at the geographical coordinates of NC 431-655 on the map of Naftshahr.
6. On 27 February 1992, at 1230 hours, six Iraqi forces - two of whom wore a red hat - aboard a Nissan Patrol vehicle entered a sentry post of the geographical coordinates of QA 305-816 on the map of Nahr-Anbar, west of border pillar 22/30 and returned back to Iraq at 1300 hours.
7. On 27 February 1992, at 1245 hours, two Iraqi forces conducted observation at the geographical coordinates of NC 430-650 on the map of Naft-Shahr.

8. From 27 February to 1 March 1992, Iraqi forces installed two rows of barbed wire behind the Manzarieh sentry post at the geographical coordinates of ND 428-049 on the map of Khosravi, west of border pillar 53.

9. On 28 February 1992, at 1000 hours, an Iraqi bus entered the sentry post - across from the Iranian Cham Sari sentry post - at the geographical coordinates of QA 28900-89250 on the map of Nahr-Anbar, south of border pillar 22/36. Five occupants got off the bus and after conducting observation of the border area through big binoculars, left the area at 1020 hours.

10. On 1 and 2 March 1992, 29 Iraqi heavy and light vehicles were observed moving at the geographical coordinates of NE 98-51 west of border pillar 95 and NE 96-52 north of border pillar 94/6 on the map of Marivan.

11. On 4 March 1992, 11 Iraqi heavy and light vehicles were observed trafficking at the geographical coordinates of NE 98-51 on the map of Marivan.

12. On 5 March 1992, six Iraqi tractors and several pick-up trucks were observed trafficking between the geographical coordinates of NE 96-53 north of border pillar 94/6 and the geographical coordinates of NE 98/51 west of border pillar 95 on the map of Marivan.

It would be highly appreciated if this letter were circulated as a document of the Security Council.
