LETTER DATED 2 NOVEMBER 1992 FROM THE PERMANENT REPRESENTATIVE
OF BOSNIA AND HERZEGOVINA TO THE UNITED NATIONS ADDRESSED TO
THE PRESIDENT OF THE SECURITY COUNCIL

Pursuant to 15 October 1992 (S/24675) and 20 October 1992 (S/24703) letters from the Presidency of the Republic of Bosnia and Herzegovina and my letters of 23 October 1992 (S/24709), 25 October 1992 (S/24717) and 29 October 1992, to the President of the Security Council with respect to gross violations of Security Council resolution 781 (1992), and;

Considering additional information from the Command of the Second Corps of the Army of the Republic of Bosnia and Herzegovina, which is attached, and which reports that the aggressor is using dust-cropping planes for military purposes in the Tuzla region, and further considering;

That the aggressor views Security Council resolution 781 (1992) inasmuch as another Security Council resolution which will not be truly implemented nor enforced;

The Presidency of the Republic of Bosnia and Herzegovina, acting under paragraph 6 of resolution 781 (1992) requests from the Security Council "to examine without delay all information brought to its attention concerning the implementation of the ban on military flights in Bosnia and Herzegovina and, in the case of violations, to consider urgently the further measures necessary to enforce this ban";

May I ask for your kind assistance in circulating this letter and its annex as a document of the Security Council.

The enemy, once again, operated its aviation in the free territory of Srebrenica.

Specifically, today, 31 October 1992 at 1045 a.m., one agricultural plane carried out an attack mission from a temporary airfield in Bratunac, and dropped two bombs on the villages of Rudak and Pole. The enemy also used a machine-gun to fire on government positions, on the line Budim-Likar, from the same airplane.

After that, a violent artillery attack began, where VBR rockets were fired and cannon and machine-guns were used from the locations in Bratunac and Rogac.

The villages of Kradjivoda and Osapi were also attacked with tank and cannon fire, coming from the slopes of Tara Mountain. Three children were injured, one child, a four-year-old girl was killed.
