OTHER APPOINTMENTS: CONFIRMATION OF THE APPOINTMENT OF
MEMBERS OF THE INVESTMENTS COMMITTEENote by the Secretary-General

1. As indicated in document A/47/104 of 18 March 1992, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of three persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 1992, of the terms of office of Mr. Yves Oltramare (Switzerland), Mr. Emmanuel Noi Omaboe (Ghana), also known as Nana Wereko Ampem II, and Mr. Jürgen Reimnitz (Germany).

2. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund (UNJSPF), the Secretary-General, after consultation with the United Nations Joint Staff Pension Board (UNJSPB) and the Advisory Committee on Administrative and Budgetary Questions (ACABQ), submits for confirmation by the General Assembly the reappointment of Mr. Yves Oltramare, Mr. Emmanuel Noi Omaboe and Mr. Jürgen Reimnitz as members of the United Nations Investments Committee for three-year terms of office beginning on 1 January 1993.

3. Mr. Oltramare has served on the Committee since 1974, Mr. Omaboe since 1980, and Mr. Reimnitz since 1975. The Secretary-General very much appreciates their willingness to carry on this important international public service.

4. The curricula vitae of the appointees for confirmation are set out in the annex to the present document.

5. In accordance with past practice, the Secretary-General also proposes to appoint as ad hoc members Mr. Peter Stormonth Darling (United Kingdom of Great Britain and Northern Ireland) and Mr. Alexander P. Papamarkou (United States of America) to serve with the Committee in 1993.
