APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

Appointment of a member of the Joint Inspection Unit

Note by the President of the General Assembly

1. As indicated in paragraph 2 of the note by the Secretary-General, (A/42/870), the General Assembly is required, during its current session, to appoint a person to fill the unexpired portion of the term of office of Mr. Nasser Kaddour (Syrian Arab Republic) as a member of the Joint Inspection Unit. Mr. Kaddour has resigned from the membership of the Unit effective 31 January 1988.
2. In accordance with the procedures described in article 3, paragraph 1, of the statute of the Joint Inspection Unit, the President of the General Assembly, having consulted the regional group concerned, determined that the Syrian Arab Republic should be requested to propose a candidate to replace Mr. Kaddour (see annex I).
3. The President of the General Assembly has held the further consultations described in article 3, paragraph 2, of the statute of the Joint Inspection Unit, including consultations with the President of the Economic and Social Council and with the Secretary-General in his capacity as Chairman of the Administrative Committee on Co-ordination. The replies received from the President of the Council and from the Secretary-General to identical letters addressed to them on 9 December 1987 by the President of the Assembly are attached (see annexes II and III).
4. Having completed the required consultations, the President of the General Assembly has the honour to submit to the Assembly the candidature of Mr. Adib Daoudy (Syrian Arab Republic) for appointment as member of the Joint Inspection Unit for a term commencing on 27 May 1988 and expiring on 31 December 1992.

Letter dated 8 December 1987 from the Permanent Representative of
