# PROGRAMME BUDGET FOR THE BIENNIUM 1992-1993

HUMAN RIGHTS QUESTIONS: HUMAN RIGHTS QUESTIONS, INCLUDING ALTERNATIVE APPROACHES FOR IMPROVING THE EFFECTIVE ENJOYMENT OF HUMAN RIGHTS AND FUNDAMENTAL FREEDOMS

Programme budget implications of draft resolution A/C.3/47/L.20/Rev.1

<u>Statement submitted by the Secretary-General in accordance with</u> <u>rule 153 of the rules of procedure of the General Assembly</u>

## A. Requests contained in the draft resolution

1. At its 40th meeting, held on 16 November 1992, the Third Committee adopted draft resolution A/C.3/47/L.20/Rev.1. A statement of programme budget implications was before the Committee in document A/C.3/47/L.25.

2. Under the terms of draft resolution A/C.3/47/L.20/Rev.1, the General Assembly would:

(a) Take note of the report of the Secretary-General 1/ and of the recommendations contained therein for the establishment of a United Nations observer mission to verify the referendum scheduled to take place in Eritrea in April 1993;

(b) Decide to authorize the Secretary-General to establish a United Nations Observer Mission to Verify the Referendum in Eritrea, which will have terms of reference as provided for in paragraph 7 of the report of the Secretary-General and to appoint, as a matter of urgency, a Special Representative for the referendum in Eritrea who will head the Observer Mission;

(c) Request the Secretary-General to arrange, as soon as possible, for the deployment of the Observer Mission so that it may commence its verification functions;

(d) Call upon the authorities directly concerned to extend their fullest cooperation to the Observer Mission in order to facilitate the accomplishment of its task as requested by the United Nations;

(e) Request the Secretary-General to report to the General Assembly at its forty-eighth session on the implementation of the resolution.

#### B. Relationship of requests to approved programme of work

3. The requests contained in paragraph 2 above are related to subprogramme 4, Enhancing the effectiveness of the principle of periodic and genuine elections, of programme 4, Special political questions, trusteeship and decolonization, which are incorporated in the revisions to the medium-term plan for the period 1992-1997, recommended by the Committee for Programme and Coordination 2/ for adoption by the General Assembly at its current session. Pursuant to General Assembly resolution 46/137 of 17 December 1991, and following the restructuring of the Secretariat, resources have been made available from the regular budget for an Electoral Assistance Unit in the Department of Political Affairs to carry out activities in support of the Secretary-General's functions in the area of holding and verification of elections as a mechanism to promote peacemaking. Specific related activities are not programmed in the programme budget since their very nature often precludes prior programming.

## C. Activities by which the requests would be implemented

4. Should the General Assembly adopt draft resolution A/C.3/47/L.20/Rev.1, the Secretary-General would establish an Observer Mission to be known as the United Nations Observer Mission to Verify the Referendum in Eritrea (UNOVER), the terms of reference of which would be as follows:

 (a) To verify the impartiality of the referendum authorities and organs, including the Referendum Commission, in all aspects and stages of the referendum process;

(b) To verify that there exists complete freedom of organization, movement, assembly and expression without hindrance or intimidation;

(c) To verify that there is equal access to media facilities and that there is fairness in the allocation of both the timing and length of broadcasts;

(d) To verify that the referendum rolls are properly drawn up and that qualified voters are not denied identification and registration cards or the right to vote;

/...

(e) To report to the referendum authorities on complaints, irregularities and interferences reported or observed and, if necessary, to request the referendum authorities to take action to resolve and rectify such complaints, irregularities or interference;

(f) To observe all activities related to the registration of voters, the organization of the poll, the referendum campaign, the poll itself and the counting, computation and announcement of the results.

5. In implementing the mandate, UNOVER would gather factual information about the conduct of the referendum, particularly with respect to the recognition by the electorate that the ultimate judgement on the referendum process will be made by the electorate. UNOVER's role will be to take note of the decision of the electorate as they determine their fate in a referendum, to recognize the independent character of the Referendum Commission and establish a relationship with it on that basis and to make constructive contributions in ensuring the success of the referendum at every stage of the process.

6. Although it had been foreseen at the time of the preparation of the Secretary-General's report 1/ that UNOVER would start during the second week of September 1992, and the estimates contained in the statement of the Secretary-General (A/C.3/47/L.25) were based on a starting date of mid-November 1993, it is now estimated that the three main phases of the referendum process would be carried out as follows:

(a) The registration of voters starting mid-December 1992;

(b) The referendum campaign during the period from mid-December 1992 to April 1993;

(c) The taking of the poll in April 1993.

The mission would then be wound up by May 1993.

7. UNOVER would be headed by a Special Representative at the Assistant Secretary-General level. Its headquarters would be located in Asmara with regional offices at Asmara, Keren and Mendefera, details of which are provided in document A/47/544. Further information is also provided in the annexes to the present statement.

8. The proposed staffing requirements of UNOVER comprise a core staff of 22 international staff members to cover the substantive and administrative functions of the mission. As can be noted from annex I to the present statement, these staff would be assigned to the mission in varying periods from mid-December 1992 to March 1993. It is estimated that, throughout the period of the mission, 10 of the core staff would form mobile observer teams of 2 persons each, who would make periodic visits to areas falling outside the jurisdiction of the regional offices area in order to provide full coverage. Although resources are requested for the 10 staff comprising the mobile

observer teams, efforts would be made to have the posts filled by United Nations Volunteers.

9. As can be noted also from annex I, it is estimated that 123 locally recruited staff would be required consisting of 3 secretaries/interpreters (for regional offices), 4 drivers (for mission headquarters and regional offices), 5 drivers and 5 interpreters (for observer teams) for approximately 5 months and 106 drivers/interpreters for approximately 2 weeks.

10. During the referendum period in April 1993, it is estimated that UNOVER personnel would be augmented by 100 election monitors to serve with the mission for approximately 5 to 10 days. It is proposed that 20 of the monitors be staff members from the Secretariat, 50 from the United Nations Development Programme (UNDP) and other United Nations agencies in Eritrea and Ethiopia and neighbouring countries and 30 would be provided by Member States. Costs associated with these additional personnel relate to round-trip travel expenses and subsistence allowance for the duration of their stay with the mission. Provision would also be made for the engagement of a consultant for three weeks to provide expert advice on the counting aspects of the referendum.

11. In respect of other requirements associated with the mission, rental of premises to accommodate UNOVER headquarters in Asmara and the three regional offices in Asmara, Keren and Mendefera is considered a requirement as no commitment has been made by the provisional government to provide office accommodation free of charge to the mission. The estimates would also provide for chartering a light aircraft once a month to transport the observer teams to remote areas of the country and for medical evacuations, should the need arise.

12. With regard to communications equipment, the requirements of UNOVER for the most part would be met by the loan of equipment from other missions or the United Nations Supply Depot at Pisa. Purchase of communications equipment would be limited to the purchase of 10 high-frequency (HF) transceivers. Other equipment requirements relate to the purchase of 9 four-wheel-drive vehicles, of which 4 would be utilized by the substantive/administrative staff and 5 by the observer teams, and electronic-data-processing equipment and other miscellaneous equipment such as camping gear, generators and water-purification kits.

13. In respect of public information activities, it is estimated that an amount of \$42,000 would be required for radio broadcasts on matters relating to the referendum and local printing of posters, flyers and other promotional materials. The provision includes requirements for the travel of a staff member of the Department of Public Information to Eritrea for two weeks to plan the information activities.

## D. <u>Modifications required in the programme of work for</u> <u>1992-1993</u>

14. As referred to in section B above, activities of the nature called for are not programmed in the programme budget for the biennium 1992-1993. Consequently, no modification will be required.

## E. Additional requirements for 1992-1993

15. Should the General Assembly adopt draft resolution A/C.3/47/L.20/Rev.1, it is estimated that requirements for the mission in 1992-1993, primarily in 1993, would amount to \$2,577,000, of which \$1,672,000 relates to personnel costs such as salaries, fees, travel and related allowances, including a contingency provision for death and disability claims for any international observers not covered by the provisions of appendix D to the United Nations Staff Rules. The balance, \$905,000, would provide for operational costs such as rental of premises, rental and acquisition of vehicles, and communications equipment and rental of aircraft. The difference between these estimates and those contained in the earlier statement of the Secretary-General (A/C.3/47/L.25) is due to the delay in the estimated start of the mission from mid-November to mid-December 1992. These revised estimated requirements are summarized below:

16. As can be noted from the above summary, the estimated requirements of 2,577,000 are also lower than the original estimate of 2,988,000 (rounded) contained in the Secretary-General's report, 1/ owing to the net effect of a later starting date for the mission and revisions and corrections of the provisional costings, shown in the Secretary-General's report. Details of the above estimated requirements are shown in annex II to the present statement,

## F. Potential for absorption

17. The programme budget for the biennium 1992-1993 includes no provision for the activities outlined above, and it is not anticipated that the related estimates of \$2,577,000 can be absorbed within the approved appropriations.

18. The financing of these activities will, therefore, require additional resources. In his statement (A/C.3/47/L.25), the Secretary-General indicated that he had made an appeal to Member States for voluntary contributions to fund UNOVER through the United Nations Trust Fund for Electoral Observation, established pursuant to General Assembly resolution 46/137 on enhancing the effectiveness of the principle of periodic and genuine elections. Although a number of Governments have indicated a willingness to make contributions-in-kind, no voluntary contributions have yet been received. In the circumstances, it will be necessary to request an additional appropriation under the regular budget.

## G. Indication of additional requirements

19. Should the General Assembly adopt draft resolution A/C.3/47/L.20/Rev.1, it is estimated that an additional requirement of \$2,577,000 would arise. As indicated in paragraph 18 above, as a result of appeals to Member States for voluntary contributions to fund UNOVER, it is expected that these requirements could be reduced upon receipt of contributions-in-kind from various Governments. In that case, any savings arising would be reflected in the second performance report of the programme budget for the biennium 1992-1993.

## H. Contingency fund

20. It will be recalled that, under the procedure established by the General Assembly in its resolution 41/213 of 19 December 1986, additional expenditures proposed over and above those in the programme budget should be accommodated within a contingency fund, revised to a level of \$18 million for the biennium 1992-1993. Paragraph 11 of annex I to General Assembly resolution 41/213, however, provides, inter alia, that revised estimates:

"arising from the impact of extraordinary expenses, including those relating to the maintenance of peace and security, as well as fluctuations in rates of exchange and inflation, shall not be covered by the contingency fund and shall continue to be treated in accordance with established procedures and under the relevant provisions of the Financial Regulations and Rules."

21. As indicated in paragraph 7 of his report, 1/ the Secretary-General sees the referendum and international supervision thereof as an integral part of the consolidation of peace. Accordingly, it is his view that the additional requirements of \$2,577,000 that would arise should the General Assembly adopt draft resolution A/C.3/47/L.20/Rev.1, are of an extraordinary nature, relating to the maintenance of peace and security and should be treated outside the procedures related to the contingency fund.

#### I. Summary

22. It is estimated that an appropriation of \$2,577,000 would be required under section 2 of the programme budget for 1992-1993. An amount of \$184,000 would also be required under section 36, Staff assessment, offset by the same amount under income section 1, Income from staff assessment. In addition, the General Assembly would need to authorize the Secretary-General to enter into commitments of up to \$103,000 for requirements in 1992, pending its approval of revised appropriations for 1992-1993.

23. The Secretary-General believes that these requirements should be dealt with under the provisions of paragraph 11 of annex I to General Assembly resolution 41/213 and should thus be treated outside the procedures related to the contingency fund.
