SPECIAL ECONOMIC AND DISASTER RELIEF ASSISTANCE

Report of the Second Committee (Part I)*

Rapporteur: Mr. Walter BALZAN (Malta)

I. INTRODUCTION

1. At its 3rd plenary meeting, on 18 September 1992, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled:

"Special economic and disaster relief assistance:

"(a) Office of the United Nations Disaster Relief Coordinator;

"(b) Special programmes of economic assistance"

and to allocate it to the Second Committee.

2. The Second Committee considered the item, together with item 88, "International assistance for the economic rehabilitation of Angola", and item 144, "International cooperation and assistance to alleviate the consequences of war in Croatia and to facilitate its recovery".

3. The items were considered at the 25th, 26th and 40th meetings, on 29 October and 16 November. Action on item 87 was taken at the 28th, 30th, 34th, 38th, 42nd, 45th, 46th, ____ meetings, on 5, 6, 10, 12, 18, 24, 25,

At the 25th meeting, on 29 October, introductory statements were made by the Under-Secretary-General for Humanitarian Affairs, the Director of the Department of Political Affairs and the Coordinator of Assistance to the Least Developed Countries, Regional Bureau for Africa of the United Nations Development Programme (see A/C.2/47/SR.25).

6. At the 40th meeting, on 16 November, an introductory statement was made by the Director of the Branch on Pacific Settlements Procedures in Africa, Department of Political Affairs (see A/C.2/47/SR.40).

II. CONSIDERATION OF DRAFT RESOLUTION A/C.2/47/L.26 AND REV.1

(b) Special programmes of economic assistance

7. At the 38th meeting, on 12 November, the representative of the <u>United</u> <u>Republic of Tanzania</u>, also on behalf of <u>Algeria</u>, <u>Angola</u>, <u>Argentina</u>, <u>Bangladesh</u>, <u>Benin</u>, <u>Botswana</u>, <u>Brazil</u>, <u>Burkina Faso</u>, <u>Burundi</u>, <u>Cape Verde</u>, <u>China</u>, <u>Gabon</u>, <u>Guatemala</u>, <u>Guinea-Bissau</u>, <u>India</u>, <u>Indonesia</u>, <u>Italy</u>, <u>Lesotho</u>, <u>Mali</u>, <u>Mauritania</u>, <u>Mozambique</u>, <u>Namibia</u>, <u>Nepal</u>, <u>Nigeria</u>, <u>Norway</u>, <u>Portugal</u>, <u>Senegal</u>, <u>Singapore</u>, <u>Spain</u>, <u>Suriname</u>, <u>Sweden</u>, <u>Tunisia</u>, the <u>United States of America</u>, <u>Vanuatu</u> and <u>Zimbabwe</u>, introduced a draft resolution (A/C.2/47/L.26) entitled "Assistance to Mozambique", which read as follows:

"The General Assembly,

"<u>Recalling</u> Security Council resolutions 386 (1976) of 17 March 1976 and 782 (1992) of 13 October 1992,

"<u>Recalling also</u> its relevant resolutions, in particular resolution 45/227 of 21 December 1990, in which it urged the international community to respond effectively and generously to the call for assistance to Mozambique,

"<u>Reaffirming</u> the principles for humanitarian assistance contained in its resolution 46/182 of 19 December 1991,

"Noting the signing at Rome, on 16 July 1992, of the Declaration on guiding principles for humanitarian assistance, which permits the expansion of relief programmes to cover all affected people in the country, and urging all parties concerned to implement the Declaration,

"<u>Welcoming</u> the signing at Rome, on 4 October 1992, of the General Peace Agreement for Mozambique, whose main goals are the establishment of lasting peace, the enhancement of democracy and the promotion of national reconciliation in that country,

"<u>Stressing</u> the need for a sustained effort by the international community to respond to the increasing and urgent emergency humanitarian needs of the people of Mozambique, in the light of the current severe drought and the evolving process of repatriation of refugees and normalization of the lives of displaced persons,

"<u>Stressing further</u> that a proper response to the current situation in Mozambique requires substantial international assistance in a comprehensive and integrated manner, linking emergency relief aid with additional rehabilitation and development assistance, "Having considered the report of the Secretary-General on assistance to Mozambique, $\underline{1}/$

"1. Takes note of the report of the Secretary-General;

"2. <u>Expresses its appreciation</u> to the Secretary-General and the relevant organizations of the United Nations system for the measures taken to organize international assistance programmes for Mozambique;

"3. <u>Expresses its gratitude</u> to all States and regional, intergovernmental and non-governmental organizations that have rendered assistance to Mozambique;

"4. Expresses its satisfaction at the entering into force, on 15 October 1992, of the General Peace Agreement, in particular the cease-fire, which creates favourable conditions for the implementation of programmes of economic and social rehabilitation and the overall process of national reconstruction;

"5. <u>Urges</u> the international community, in particular the United Nations system, to extend its full support and contribute to the peace-building process in Mozambique in accordance with the General Peace Agreement, providing, <u>inter alia</u>, assistance for the electoral process, emergency and rehabilitation assistance for refugees and displaced persons and support for programmes of demobilization of armed forces;

"6. <u>Notes with appreciation</u> the establishment, in Mozambique, of a Committee on Humanitarian Assistance, with the participation of the United Nations, and the formulation of a unified plan for the delivery of relief assistance throughout the country;

"7. <u>Draws the attention</u> of the international community to the unmet funding needs referred to in the 1992/93 Emergency Programme for Mozambique and the United Nations/Southern Africa Development Community Appeal for the Drought Emergency in Southern Africa;

"8. "<u>Calls upon</u> all States, regional and interregional organizations, other intergovernmental organizational and international non-governmental organizations to intensify their development cooperation and assistance in support of the process of national reconstruction of Mozambique;

"9. <u>Requests</u> the Secretary-General, in close cooperation with the Government of Mozambique:

"(a) To continue his efforts to mobilize the international assistance required by Mozambique;

"(b) To ensure the coordination of the work of the United Nations system for an adequate response to the emergency, rehabilitation and development needs of Mozambique;

"(c) [To prepare a report on assistance to Mozambique for submission to the General Assembly at its forty-ninth session.]"

8. At its 45th meeting, on 24 November, the Committee had before it a revised draft resolution (A/C.2/47/L.26/Rev.1) submitted by the sponsors of draft resolution A/C.2/47/26 joined by <u>El Salvador, Iran (Islamic Republic of), Kenya, Malawi, Poland, Thailand, Uganda</u> and the <u>United Kingdom of Great Britain and Northern Ireland</u>. Subsequently, <u>Colombia, Finland</u> and <u>Zambia</u> joined in sponsoring the revised draft resolution.

9. The Committee was informed that the draft resolution contained no programme budget implications.

10. At the same meeting, the Committee adopted draft resolution A/C.2/47/L.26/Rev.1 without a vote (see para. 11).

III. RECOMMENDATION OF THE SECOND COMMITTEE

11. The Second Committee recommends to the General Assembly the adoption of the following draft resolution:

Assistance to Mozambique

The General Assembly,

Recalling Security Council resolutions 386 (1976) of 17 March 1976 and 782 (1992) of 13 October 1992,

Recalling also its relevant resolutions, in particular resolution 45/227 of 21 December 1990, in which it urged the international community to respond effectively and generously to the call for assistance to Mozambique,

<u>Reaffirming</u> the principles for humanitarian assistance contained in its resolution 46/182 of 19 December 1991,

Noting the signing at Rome, on 16 July 1992, of the Declaration on Guiding Principles for Humanitarian Assistance, which permits the expansion of relief programmes to cover all affected people in the country, and urging all parties concerned to implement the Declaration, <u>Welcoming</u> the signing at Rome, on 4 October 1992, of the General Peace Agreement for Mozambique, 2/ whose main goals are the establishment of lasting peace, the enhancement of democracy and the promotion of national reconciliation in that country,

Stressing the need for a sustained effort by the international community to respond to the increasing and urgent emergency humanitarian needs of the people of Mozambique, in the light of the current severe drought and the evolving process of repatriation of refugees and normalization of the lives of displaced persons,

<u>Stressing also</u> that a proper response to the current situation in Mozambique requires substantial international assistance in a comprehensive and integrated manner, linking emergency relief aid with additional rehabilitation and development assistance,

<u>Having considered</u> the report of the Secretary-General on assistance to Mozambique, $\underline{3}/$

<u>Takes note</u> of the report of the Secretary-General;

2. <u>Expresses its appreciation</u> to the Secretary-General and the relevant organizations of the United Nations system for the measures taken to organize international assistance programmes for Mozambique;

3. <u>Expresses its gratitude</u> to all States and regional, intergovernmental and non-governmental organizations that have rendered assistance to Mozambique;

4. <u>Expresses its satisfaction</u> at the entry into force, on 15 October 1992, of the General Peace Agreement, in particular the cease-fire, which creates favourable conditions for the implementation of programmes of economic and social rehabilitation and the overall process of national reconstruction;

5. <u>Urges</u> the international community, in particular the United Nations system, to extend its full support and contribute to the peace-building process in Mozambique in accordance with the General Peace Agreement, providing, <u>inter alia</u>, assistance for the electoral process, emergency and rehabilitation assistance for refugees and displaced persons and support for programmes of demobilization of armed forces;

6. <u>Also urges</u> the international community, in the context of paragraph 5 above, to support and participate actively in the forthcoming conference of donor countries and organizations, to be held at Rome on 15 and 16 December 1992;

7. <u>Notes with appreciation</u> the establishment, in Mozambique, of a Committee on Humanitarian Assistance, with the participation of the United Nations, and the formulation of a unified plan for the delivery of relief assistance throughout the country;

8. <u>Draws the attention</u> of the international community to the unmet funding needs referred to in the 1992/93 Emergency Programme for Mozambique and the United Nations/Southern Africa Development Community Appeal for the Drought Emergency in Southern Africa;

9. <u>Calls upon</u> all States, regional and interregional organizations, other intergovernmental organizations and international non-governmental organizations to intensify their development cooperation and assistance in support of the process of national reconstruction of Mozambique;

10. <u>Requests</u> the Secretary-General, in close cooperation with the Government of Mozambique:

(a) To continue his efforts to mobilize the international assistance required by Mozambique;

(b) To ensure the coordination of the work of the United Nations system for an adequate response to the emergency, rehabilitation and development needs of Mozambique;
