Note by the Secretary-General

Addendum

1. The Commission on Human Rights, at its forty-fourth session, in accordance with the relevant resolutions of the Economic and Social Council, is called upon to elect members of the Sub-Commission on Prevention of Discrimination and Protection of Minorities. The Secretary-General, in document E/CN.4/1988/46, informed the Commission of the nominations of candidates and alternates for election to the Sub-Commission received as at 16 December 1987. That document also contained the biographical data of candidates and alternates which had been received.
2. Additional nominations and biographical data and some changes of nominations have been received since 16 December 1987- The present document reflects the information received since that date and includes the biographical data not reproduced in document E/CN.4/1988/46. On 26 January 1988 the Government of the Syrian Arab Republic informed the Secretary-General that it had decided to withdraw the nomination of Mr. Adib Daoudy.
3. The present document contains the list of nominations for membership of the Sub-Commission as at 5 February 1988, including all changes which the Secretary-General had received by that date from Governments. This document also contains biographical data received since 16 December 1987 in an annex. Information received subsequent to the date of the present document (5 February 1988) will be reproduced in addenda.

Immediately before his arrival in Geneva Mr. Rashid was Additional Foreign Secretary, Government of Bangladesh.

Born in Dhaka in 1934, Mr. Harun-ur-Rashid received his education in Bangladesh, England, Holland and in the USA. He obtained B.A.(Hons) and M.A. from Dhaka University in 1956-57. He earned the degree of Barrister-at-Law from Lincoln's Inn, London in 1961. He also took post-graduate training and diploma from The Hague Institute of International Law.

Mr. Rashid held various important assignments at home and abroad. He had been Ambassador of Bangladesh to Nepal (1981-1982) and to the Philippines (1984-1986). He also served as Bangladesh High Commissioner to Australia and New Zealand (1982-1984).

Mr. Rashid represented Bangladesh in many international conferences and seminars. He was deputy leader of the Bangladesh delegation to the UN Law of the Sea Conference in Venezuela; New York and Geneva during 1974-76. Mr. Rashid spent sometime on a special assignment in the UN Secretariat, New York in 1969.
