Ms. LIDIJA R. BASTA (Alternate)

(Nominated by the Government of Yugoslavia)

Dr. Lidija R. Basta was born 23 August 1948, Belgrade, Yugoslavia. She completed her secondary education in 1967 and graduated in law at the University of Belgrade in 1971. After having passed her M.A., and Ph.D., examinations in 1974 and 1975 respectively, she obtained her doctor's degree with a dissertation "Constitutionalism in Theory and Practice" (1982).

Since 1974 Dr. Basta has been working with the Belgrade Institute of Comparative Law, currently as a Senior Research Fellow.

Dr. Basta was fellow of the One hundred and forty-first session (The Changing American Political Scene) of the Salzburg Seminar in American Studies (1972) and of the thirteenth session of the Leyden-Amsterdam-Columbia Summer Programme in American Law (1975). While preparing her doctoral thesis, Ms. L. Basta worked at the King's College Centre for European Studies and the Institute of Advanced Legal Studies in London (1976). As a fellow of the Max-Planck Foundation, Dr. Basta spent eight months in the Federal Republic of Germany in 1984 and worked as a guest researcher at the Max-Planck Institute for European Legal History in Frankfurt.

Dr. Basta sat on the editorial boards of the two well known Yugoslav periodicals: "Gledista" (Viewpoints, 1979-1980) and "Marksisticka misao" (Marxist Thought, 1982-1986), and is for more than 10 years now public editor of the "Strani pravni zivot" (Foreign Legal Issues)

Dr. L.R. Basta is Deputy Secretary-General of the International Association of Constitutional Law.

The main field of her scientific interest covers comparative constitutional law, including individual rights and freedoms and constitutional review issues, as well as constitutional and political theory. She is author of more than 50 short studies, articles and reports, published both in Yugoslav and foreign leading legal periodicals and collections of papers. In 1984 she published a book "Politics under Law".

Dr. Basta participated in a number of congresses in Yugoslavia and abroad, coloquia and round-table conferences. She also lectured at the Salzburg Seminar Reunion Session (1977), the Max-Planck Institute for European Legal History (1984) and the Faculty of Law, University of Thessaloniki (1985).
