#### Τ. INTRODUCTION

At its 3rd plenary meeting, on 18 September 1992, the General Assembly, 1. on the recommendation of the General Committee, decided to include in the agenda of its forty-seventh session the item entitled:

"International cooperation for economic growth and development:

- "(a) Implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of the Economic Growth and Development of the Developing Countries;
- "(b) Implementation of the International Development Strategy for the Fourth United Nations Development Decade"

and to allocate it to the Second Committee.

The Second Committee considered the item at its 12th, 13th, 22nd and 2. 45th meetings, on 12, 27 October and 24 November 1992. An account of the

Committee's discussion of the item is contained in the relevant summary records (A/C.2/47/SR.12, 13, 22 and 45). Attention is also drawn to the general debate held by the Committee at its 3rd to 9th meetings, from 5 to 8 October (see A/C.2/47/SR.3-9).

#### (b) <u>Implementation of the International Development Strategy</u> for the Fourth United Nations Development Decade

(p) Report of the Secretary-General on the implementation of the International Development Strategy for the Fourth United Nations Development Decade (A/47/270-E/1992/74).

4. At the 12th meeting, on 12 October, the Director of the Division of Development Policy and Analysis of the Department of Economic and Social Development of the Secretariat made an introductory statement (see A/C.2/47/SR.12).

#### II. CONSIDERATION OF DRAFT RESOLUTION A/C.2/47/L.9

5. At the 22nd meeting, on 27 October, the representative of <u>Pakistan</u>, speaking on behalf of the States Members of the United Nations that are also members of the Group of 77, introduced a draft resolution ( $\lambda/C.2/47/L.9$ ) entitled "International cooperation for economic growth and development".

6. At the 45th meeting, on 24 November, the Vice-Chairman of the Committee, Mr. Jose Lino B. Guerrero (Philippines), informed the Committee of the results of the informal consultations held on the draft resolution.

7. At the same meeting, the Committee adopted draft resolution A/C.2/47/L.9 without a vote (see para. 8).

#### III. RECOMMENDATION OF THE SECOND COMMITTEE

8. The Second Committee recommends to the General Assembly the adoption of the following draft resolution:

#### International cooperation for economic growth and development

#### The General Assembly,

<u>Reaffirming</u> the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, contained in the annex to its resolution S-18/3 of 1 May 1990, and the International Development Strategy for the Fourth United Nations Development Decade, contained in the annex to its resolution 45/199 of 21 December 1990, which provide the overall framework for economic growth and development,

<u>Recalling</u> its resolution 46/144 of 17 December 1991 on the implementation of the commitments and policies agreed upon in the Declaration,

<u>Taking into account</u> the Cartagena Commitment, 1/ the United Nations New Agenda for the Development of Africa in the 1990s, 2/ the Programme of Action for the Least Developed Countries for the 1990s, 3/ and Agenda 21 4/ and all the relevant decisions of the United Nations Conference on Environment and Development,

 <u>Takes note with interest</u> of the relevant reports of the Secretary-General on the subject; <u>5</u>/

2. <u>Encourages</u> Member States to submit their reports on the implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries;

3. <u>Requests</u> the Secretary-General to provide, at its forty-ninth session, an analytical and comprehensive report on implementation of the commitments and policies agreed upon in the Declaration and on implementation of the International Development Strategy for the Fourth United Nations Development Decade, including his assessment of the steps taken by Governments of developed and developing countries, individually and collectively, and by organs, organizations and bodies of the United Nations system, including regional commissions;

4. Decides, in order to keep the implementation of the Declaration and the International Development Strategy under review, to include in the provisional agenda of its forty-eighth session the item entitled "International cooperation for economic growth and development:
(a) Implementation of the commitments and policies agreed upon in the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries;
(b) Implementation of the International Development Strategy for the Fourth United Nations Development Decade".
