#### I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 18 September 1992, the General Assembly decided to include in the agenda of its forty-seventh session the item entitled "Programme budget for the biennium 1992-1993" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 14th to 17th, 19th, 20th, 23rd, 28th, 29th, 32nd, 35th, 37th to 40th, 42nd to 45th, 47th, 49th to 52nd meetings, on 26, 29, 30 October, on 2, 4, 5, 10, 18, 19, 25 November, and 1, 7 to 9, 11, 13 to 15, 17 to 21 December 1992.
- 3. The comments and observations made in the course of the discussion of the item are reflected in the relevant summary records (A/C.5/47/SR.14-17, 19-20, 23, 28-29, 32, 35, 37-39, 40, 42-45 and 47-52).
- 4. In accordance with the guidelines for the contingency fund, annexed to General Assembly resolution 42/211 of 21 December 1987, the Fifth Committee, at its 51st meeting, on 20 December 1992, considered a consolidated statement of all programme budget implications and revised estimates that were subject to the criteria for the use of the contingency fund and the corresponding report of the Advisory Committee on Administrative and Budgetary Questions, which was presented orally. The consolidated amount fell within the available balance of the contingency fund. The Committee, therefore, proceeded to approve the required amounts under the relevant sections of the programme budget.
- 5. Section II of the present report contains a summary of the recommendations of the Fifth Committee during the current session on the revised estimates submitted by the Secretary-General and on the programme budget implications of resolutions adopted by the General Assembly, either on the recommendation of its Main Committees or in respect of items dealt with in plenary meetings.
- 6. Section III of the report provides a summary of the special subjects considered by the Fifth Committee, other than the programme budget implications of draft resolutions, which led to the adoption of specific decisions to be recommended to the General Assembly.
- 7. The recommendations of the Fifth Committee are contained in section IV of the present report.

#### II., PROGRAMME BUDGET FOR THE BIENNIUM 1992-1993

8. By its resolutions 46/186 A and B of 20 December 1991, the General Assembly approved appropriations for the biennium 1992-1993 in the amount of \$2,389,234,900 and estimates of income in the amount of \$449,213,300.

- 9. Recommendations of the Fifth Committee during the current session of the General Assembly on revised estimates submitted by the Secretary-General, as well as on the programme budget implications of resolutions adopted by the Assembly under items considered by other Main Committees or in respect of items dealt with in plenary meetings, have resulted in net increases in the approved level of appropriations in the amount of \$78,804,300 and net increases in the approved estimates of income in the amount of \$21,803,100.
- 10. The revised estimates of expenditure and income approved by the Fifth Committee and the financial implications of resolutions recommended by other Main Committees and subsequently by the General Assembly are indicated, by expenditure and income section, below:

#### III. CONSIDERATION OF SPECIAL SUBJECTS

#### First report of the Advisory Committee on Administrative and Budgetary Questions

- 12. The Committee considered the first report of the Advisory Committee ( $\lambda/47/7$ ) at its 32nd meeting, on 25 November 1992.
- 13. At the same meeting, the Committee decided, without a vote, to recommend to the General Assembly that it take note with appreciation of the first report of the Advisory Committee on Administrative and Budgetary Questions (see para. 77, draft resolution I, sect. I).

### Construction of additional conference facilities at Addis Ababa and Bangkok

- 14. The Committee considered this question at its 32nd meeting, on 25 November 1992. It had before it the report of the Secretary-General (A/C.5/47/11) and the related report of the Advisory Committee (A/47/7/Add.2).
- 15. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly take note of the report of the Secretary-General on the construction of additional conference facilities at Addis Ababa and Bangkok and concur with the recommendations and request made by the Advisory Committee on Administrative and Budgetary Questions in paragraph 4 of its report (see para. 77, draft resolution I, sect. II).

## 3. Recommendation of the Advisory Board on Disarmament Matters

16. The Committee considered this question at its 32nd meeting, on 25 November. It had before it the report of the Secretary-General (A/C.5/47/19). The report of the Advisory Committee was presented orally by its Chairman.

- 17. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly approve the recommendations of the Advisory Board on Disarmament Matters of a subvention of \$220,000 from the regular budget of the United Nations for 1993 on the understanding that the level of support cost charged to the United Nations Institute for Disarmament Research would be kept under review (see para. 77, draft resolution I, sect. III).
  - 4. Revised estimates resulting from resolutions and decisions of the Economic and Social Council at its substantive session of 1992
- 18. The Committee considered this question at its 32nd and 45th meetings, on 25 November and 15 December. At its 32nd meeting, the Committee had before it the report of the Secretary-General (A/C.5/47/21) and the related report of the Advisory Committee (A/47/7/Add.4). At its 45th meeting, the Committee had before it the report of the Secretary-General (A/C.5/47/21/Add.1). The related report of the Advisory Committee was presented orally by its Chairman.
- 19. At its 32nd meeting, the Committee decided, without a vote, to take note of the additional requirements resulting from resolutions and decisions of the Economic and Social Council at its substantive session in 1992 estimated at \$292,500, on the understanding that such additional appropriations as may be requested by the Secretary-General will be submitted in the context of a consolidated statement to be issued to the General Assembly towards the end of its forty-seventh session, in accordance with the Assembly resolution 42/211 of 21 December 1987 (see para, 77, draft resolution I, sect. IV).
- 20. At its 45th meeting, the Committee decided, without a vote, to approve the additional requirements estimated at \$71,300 under section 21 (International drug control) of the programme budget for 1992-1993, on the understanding that such additional appropriations would be subject to the guidelines for the use and operation of the contingency fund adopted by the General Assembly in its resolution 42/211 and on the understanding that the Secretary-General will consider possible redeployment in the context of his revised estimates to be presented to the General Assembly in early 1993 (see para. 77, draft resolution I, sect. IV).

#### 5. International Computing Centre: 1993 budget estimates

- 21. The Committee considered this question at its 32nd meeting, on 25 November 1992. It had before it the report of the Secretary-General (A/C.5/47/24 and Corr.1). The report of the Advisory Committee was presented orally.
- 22. At the same meeting, the Committee decided, without a vote, to recommend to the General Assembly that it approve the budget estimates of the International Computing Centre for the year 1993 amounting to \$13,789,700 or SwF 19,719,300, as indicated in the report of the Secretary-General

( $\lambda/C.5/47/24$  and Corr. 1), and to request that future budgets of the International Computing Centre be presented in a format consistent with the unique nature of the budget of the Centre (see para. 77, draft resolution I, sect. V).

- 6. Administrative arrangements for the secretariat of the United Nations Scientific Committee on the Effects of Atomic Radiation
- 23. The Committee considered this question at its 35th meeting, on 1 December 1992. It had before it the report of the Secretary-General (A/C.5/47/26) and the related report of the Advisory Committee (A/47/7Add.3).
- 24. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly request the Secretary-General to explore possible alternatives for the organizational location and administrative support arrangements for the secretariat of the United Nations Scientific Committee on the Effects of Atomic Radiation (see para. 77, draft resolution I, sect. VI).

# 7. <u>Level of secretaries of intergovernmental</u> <u>policy-making organs</u>

- 25. The Committee considered this question at its 35th meeting, on 1 December 1992. It had before it the report of the Secretary-General (A/C.5/47/28). The report of the Advisory Committee was presented orally.
- 26. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly request the Secretary-General to review the situation in the context of the preparation of the proposed programme budget for the biennium 1994-1995 (see para. 77, draft resolution I, sect. VII).
  - 8. Revised estimates under section 24 (Economic and Social Commission for Asia and the Pacific)
- 27. The Committee considered this question at its 37th meeting, on 7 December 1992. It had before it the report of the Secretary-General ( $\lambda/C.5/47/29$ ) and the related report of the Advisory Committee ( $\lambda/47/7/\lambda$ dd.7, paras. 2-5).
- 28. At the same meeting, the Committee decided, without a vote, to endorse the recommendations of the Advisory Committee contained in paragraph 5 of its report and noted that, should there be a need for additional expenditures in relation to the revised estimates proposed by the Secretary-General for section 24, such expenditures would be reflected in the final performance report under section 24 of the programme budget for the biennium 1992-1993 (see para. 77, draft resolution I, sect. VIII).

## Revised estimates under section 21D (Crime prevention and criminal justice)

- 29. The Committee considered this question at its 37th meeting, on 7 December. It had before it the report of the Secretary-General ( $\lambda/C.5/47/40$ ) and the related report of the Advisory Committee ( $\lambda/47/7/\lambda$ dd.7, paras. 6-15).
- 30. The Committee decided, without a vote, to endorse the proposals of the Secretary-General and the recommendations of the Advisory Committee in paragraph 15 of its report (see para, 77, draft resolution I, sect. IX).

# 10. Revised estimates under section 27 (Economic and Social Commission for Western Asia)

- 31. The Committee considered this question at its 37th meeting, on 7 December. It had before it the report of the Secretary-General (A/C.5/47/41) and the related report of the Advisory Committee (A/47/7/Add.7, paras. 16-19).
- 32. At the same meeting, the Committee decided, without a vote, to endorse the proposals of the Secretary-General in paragraph 5 of his report and the recommendations of the Advisory Committee in paragraph 19 of its report (see para. 77, draft resolution I, sect. X).

# 11. Representation allowance for under-secretaries-general and assistant secretaries-general

- 33. The Committee considered this question at its 37th meeting, on 7 December. It had before it the reports of the Secretary-General (A/C.5/46/32 and Corr. 1 and A/C.5/47/39) and the related reports of the Advisory Committee (A/46/7/Add.8 and A/47/7/Add.6).
- 34. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly defer consideration of this item, taking into account views expressed by delegations during the consideration of this item, and that a further review be undertaken, as soon as possible, in the light of future decisions to be taken on the restructuring of the Secretariat (see para. 77, draft resolution I, sect. XI).

# 12. Institute for Economic Development and Planning and Multinational Programming and Operational Centres of the Economic Commission for Africa

35. The Committee considered this question at its 38th meeting, on 8 December. It had before it the report of the Secretary-General (A/C.5/47/53). The report of the Advisory Committee was presented orally.

36. At the same meeting, the Committee decided, without a vote, to endorse the proposals of the Secretary-General and the observations of the Advisory Committee concerning the Institute for Economic Development and Planning and the Multinational Programming and Operational Centres (see para. 77, draft resolution I, sect. XII).

# 13. Status of technological innovations in the United Nations and progress report on the optical disk project

- 37. The Committee considered this question at its 43rd meeting, on 13 December. It had before it the report of the Secretary-General (A/C.5/47/18 and Add.1) and the related report of the Advisory Committee (A/47/7/Add.8).
- 38. At the same meeting, the Committee decided, without a vote, to take note of the report of the Secretary-General and to endorse the recommendations of the Advisory Committee contained in paragraphs 34, 36 and 37 of its report (see para. 77, draft resolution I, sect. XIII).

- 39. The Committee considered this question at its 43rd meeting, on 13 December. It had before it the report of the Secretary-General ( $\lambda/C.5/47/27$ ) and the related report of the Advisory Committee ( $\lambda/47/7/\lambda dd.8$ ).
- 40. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly take note of the report of the Secretary-General and endorse the recommendations of the Advisory Committee contained in paragraphs 21 to 32 of its report (see para. 77, draft resolution I, sect. XIV).

# 15. Revised estimates under section 28 (Human rights)

- 41. The Committee considered this question at its 45th and 50th meetings, on 15 and 19 December. It had before it the report of the Secretary-General (A/C.5/47/71). The report of the Advisory Committee was presented orally by its Chairman.
- 42. At its 50th meeting, the Committee decided, without a vote, to recommend that the General Assembly endorse the proposal of the Secretary-General in his report, but, with regard to his request for \$760,000, decided that the Secretary-General should implement, within the overall level of the revised appropriation for 1992-1993, the other activities of the Centre for Human Rights, for which he has requested additional resources, and would report to the General Assembly through the final budget performance report for 1992-1993 (see para. 77, draft resolution I, sect. XVI).

- 16. Revised estimates under section 38 (Legal activities): Commission of Experts established pursuant to Security Council resolution 730 (1992)
- 43. The Committee considered this question at its 49th meeting, on 18 December 1992. It had before it the report of the Secretary-General (A/C.5/47/68). The report of the Advisory Committee was presented orally by its Chairman.
- 44. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly approve an additional appropriation of \$646,700, on the understanding that these requirements would be treated outside the procedures related to the contingency fund (see para. 77, draft resolution I, sect. XVII).
  - 17. Revised estimates under section 31 (Public information): establishment of seven United Nations interim offices
- 45. The Committee considered this question at its 45th and 47th meetings, on 15 and 17 December. It had before it the report of the Secretary-General (A/C.5/47/58 and A/C.5/47/CRP.3/Rev.1). The report of the Advisory Committee was presented orally by its Chairman.
- 46. At its 47th meeting, the Committee decided, without a vote, to recommend that the General Assembly request the Secretary-General to re-submit a complete report on the establishment and operation of the seven United Nations interim offices, including staffing, project implementation and an integrated budget with full sources of financing, at its resumed forty-seventh session, in accordance with the relevant resolutions and decisions of the competent United Nations bodies regarding operational activities and public information activities and taking into account the views expressed by the Member States in the Fifth Committee on this issue during its forty-seventh session (see para. 77, draft resolution I, sect. XVIII).

#### 18. United Nations Observer Mission in South Africa

- 47. The Committee considered this question at its 50th meeting, on 19 December 1992. It had before it the report of the Secretary-General (A/C.5/47/79). The report of the Advisory Committee was presented orally by its Chairman.
- 48. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly approve an appropriation of \$13,121,300, under section 2 (Peace-keeping operations and special missions) of the programme budget for the biennium 1992-1993, on the understanding that these requirements would be treated outside the procedures relating to the contingency fund (see para. 77, draft resolution I, sect. XIX).

# 19. Recommendations made by the Committee for Programme and Coordination at its thirty-second session

- 49. The Committee considered this question at its 50th meeting, on 19 December. It had before it the programme budget implications of recommendations of the Committee for Programme and Coordination in 1992 (A/47/16 (Parts I and II) and Add.1 and 2). The report of the Advisory Committee was presented orally by its Chairman.
- 50. At the same meeting, the Committee decided to recommend to the General Assembly that it take note of the information and observations provided by the Chairman of the Committee for Programme and Coordination and the Advisory Committee and recommended that the 27th series of joint meetings take place in New York (see para. 77, draft resolution I, sect. XX).

# 20. Installation of appropriate signalling system

- 51. The Committee considered this question at its 50th meeting, on 19 December 1992. It had before it the report of the Committee on Conferences  $(\lambda/47/32)$  and a statement of programme budget implications  $(\lambda/C.5/47/23)$ . The report of the Advisory Committee was presented orally by its Chairman.
- 52. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly endorse the comments and recommendations of the Advisory Committee with respect to the installation of an appropriate signalling system (see para. 77, draft resolution I, sect. XXI).
  - 21. Administrative and financial arrangements regarding the United Nations International Drug Control Programme
- 53. The Committee considered this question at its 50th meeting, on 19 December. It had before it a note by the Secretariat (A/C.5/47/44).
- 54. At the same meeting, the Committee decided, without a vote, to recommend to the General Assembly that it take note of the note of the Secretariat on the administrative and financial arrangements regarding the United Nations International Drug Control Programme (see para. 77, draft resolution I, sect. XXII).

## 22. Programme on Space Applications

55. The Committee considered this question at its 50th meeting, on 19 December. It had before it a letter from the Chairman of the Special Political Committee to the Chairman of the Fifth Committee (A/C.5/47/51). The report of the Advisory Committee was presented orally by its Chairman.

56. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly take note of the letter dated 30 October 1992 from the Chairman of the Special Political Committee to the Chairman of the Fifth Committee regarding the budgetary allocations for the programme on space applications (see para. 77, draft resolution I, sect. XXIII).

### 23. United Nations Institute for Training and Research

- 57. The Committee considered this question at its 50th meeting, on 19 December. It had before it a statement on the programme budget implications (A/C.5/47/82) of draft resolution II entitled "United Nations Institute for Training and Research" (A/C.2/47/L.91) recommended by the Second Committee in paragraph 21 of its report (A/47/729).
- 58. The Committee decided, without a vote, to recommend to the General Assembly, in order to provide for the minimal transitional requirements for the United Nations Institute for Training and Research (UNITAR) until the General Assembly can consider this matter at its resumed forty-seventh session, that the Secretary-General be authorized to commit funds, not to exceed \$400,000 with the concurrence of the Advisory Committee, for the period 1 January through 28 February 1993, by advances from the Working Capital Fund, to cover all costs related to the provision of security and maintenance of the UNITAR premises, as well as the costs of maintaining the existing staff members of the UNITAR New York office for whom placement is to be sought elsewhere within the United Nations system, in accordance with General Assembly resolution 42/197 of 11 December 1987 (see para. 77, draft resolution I, sect. XXIV).

## 24. Travel of representatives to the second part of the thirty-third session of the Committee for Programme and Coordination

- 59. The Committee considered this question at its 50th meeting, on 19 December 1992. It had before it a statement on the programme budget implications (A/C.5/47/84) of draft decision A/C.5/47/L.26. The report of the Advisory Committee was presented orally by its Chairman.
- 60. At the same meeting, the Committee decided, without a vote, to recommend to the General Assembly that, should it adopt the draft decision contained in document A/C.5/47/L.26, an additional appropriation of \$86,400 would be required under section 1 (Overall policy-making, direction and coordination) of the programme budget for the biennium 1992-1993 (see para. 77, draft resolution I, sect. XXV, and para. 78, draft decision I)).

### 25. First programme budget performance report

- 61. The Committee considered this question at its 49th and 50th meetings, on 18 and 19 December 1992. It had before it the report of the Secretary-General (A/C.5/47/47). The report of the Advisory Committee was presented orally by its Chairman.
- 62. At its 50th meeting, the Committee decided, without a vote, to recommend to the General Assembly that it take note of the report of the Secretary-General on the first programme budget performance report and approve the revised requirements submitted by the Secretary-General, and to request him to take steps to improve the performance report in order to make its presentation more timely and more transparent. It also recommended to the General Assembly that it urge the International Civil Service Commission to review staff assessment rates in 1993 (see para. 77, draft resolution I, sect. XXVI).
  - 26. Section 15 (United Nations Conference on Trade and Development): report of the Secretary-General on the thirteen posts formerly attached to the subprogramme on trade among countries having different economic and social systems
- 63. The Committee considered this question at its 51st meeting, on 20 December. It had before it the report of the Secretary-General (A/C.5/47/7) and the related report of the Advisory Committee (A/47/7/Add.1).
- 64. At the same meeting, the Committee endorsed the recommendations of the Committee for Programme and Coordination and the Advisory Committee, as contained in their respective reports (see para. 77, draft resolution I, sect. XXVII).

#### 27. Staff assessment

- 65. The Committee considered this question at its 51st meeting, on 20 December. It had before it a draft decision submitted by the Chairman (A/C.5/47/L.28).
- 66. At the same meeting, the Committee decided to request the Secretary-General to review all aspects of the question of staff assessment as they affect the budgets of the United Nations organizations and programmes, taking into account the views of the International Civil Service Commission and the experience of other organizations of the system, and established principles and practices, including the principle of ensuring equality of pay and benefits for all staff members, and to present proposals to the General Assembly at its forty-eighth session, through the Commission (see para. 78, draft decision II).

- 28. Comprehensive study of the question of honoraria payable to members of organs and subsidiary organs of the United Nations
- 67. The Committee considered this question at its 43rd and 51st meetings, on 13 and 20 December. It had before it the reports of the Secretary-General (A/C.5/46/12 and A/C.5/47/45) and the related reports of the Advisory Committee (A/46/7/Add.8 and A/47/7/Add.10).
- 68. At its 51st meeting, the Committee decided, without a vote, to recommend to the General Assembly that it postpone to its resumed session the review of the whole question of honoraria and authorized the Secretary-General, pending the results of the review, to take appropriate measures on an exceptional basis and with the concurrence of the Advisory Committee on Administrative and Budgetary Questions with regard to paragraph 55 of his report within the overall framework of the current pertinent resolutions and decisions. It also recommended that the Secretary-General reflect the measures he will take in the final performance report for the biennium 1992-1993 and revert to this matter again at its forty-eighth session (see para. 77, draft resolution I, sect. XV).
  - 29. Recosting of decisions of the Fifth Committee concerning statements of programme budget implications and revised estimates
- 69. The Committee considered this question at its 51st meeting, on 20 December. It had before it the report of the Secretary-General (A/C.5/47/86). The report of the Advisory Committee was presented orally by its Chairman.
- 70. At the same meeting, the Committee decided to recommend that the General Assembly approve an increase of \$121,300 under the expenditure sections and an increase of \$18,500 under income section 1 of the programme budget for the biennium 1992-1993 following the recosting of decisions of the Fifth Committee concerning statements of programme budget implications and revised estimates (see para. 77, draft resolution I, sect. XXIX).
  - 30. Granting of travel assistance to least developed and other developing countries that are members of the United Nations Commission on International Trade Law
- 71. The Committee considered this question at its 23rd, 28th and 51st meetings, on 10 and 18 November and 20 December. It had before it the reports of the Secretary-General (A/45/349, A/47/454 and A/C.5/47/CRP.1).
- 72. At its 51st meeting, the Committee decided, without a vote, to recommend to the General Assembly that it defer consideration of this item to its resumed forty-seventh session (see para. 77, draft resolution I, sect. XXX).

# 31. Deferral of items

- 73. The Committee considered this question at its 52nd meeting, on 21 December. It had before it a draft decision submitted by the Chairman (A/C.5/47/L.31).
- 74. At the same meeting, the Committee decided, without a vote, to approve the draft decision (see para. 78, draft decision III).

## 32. The contingency fund

- 75. The Committee considered this question at its 51st meeting, on 20 December. It had before it the report of the Secretary-General (A/C.5/47/85). The report of the Advisory Committee was presented orally by its Chairman.
- 76. At the same meeting, the Committee decided, without a vote, to recommend that the General Assembly appropriate the required amounts, as contained in the report of the Secretary-General, as orally revised. The Committee also decided to recommend to the General Assembly that it note that a balance of \$11,753,700 would remain in the contingency fund (see para. 77, draft resolution I, sect. XXVII).

Budget appropriations in a total amount of 1,273,421,750 United States dollars, consisting of 1,194,617,450 dollars, being half of the appropriations initially approved for the biennium 1992-1993 by General Assembly resolution 46/186 A of 20 December 1991, plus 78,804,300 dollars, being the increase in the appropriations approved during the forty-seventh session by resolution A above, shall be financed in accordance with regulations 5.1 and 5.2 of the Financial Regulations of the United Nations as follows:
  - (a) 40,176,315 dollars, consisting of:
  - (i) An amount of 28,368,850 dollars, which is the net of 34,643,650 dollars, being half of the estimated income approved for the biennium 1992-1993 by its resolution 46/186 B of 20 December 1991 other than staff assessment income, offset by an amount of 6,274,800 dollars, being the decrease in estimated income other than staff assessment income approved by resolution B above;
  - (ii) 11,807,465 dollars, being the balance of the surplus account as at 31 December 1991;
- (b) 1,233,245,435 dollars, being the assessment on Member States in accordance with General Assembly resolution 46/221 A of 20 December 1991 and \_\_\_\_\_ of 21 December 1992 on the scale of assessments for the years 1992, 1993 and 1994.
- 2. There shall be set off against the assessment on Member States, in accordance with the provisions of General Assembly resolution 973 (X) of 15 December 1955, their respective share in the Tax Equalization Fund in the total amount of 218,040,900 dollars, consisting of:
- (a) 189,963,000 dollars, being half of the estimated staff assessment income approved by resolution 46/186 B;
- (b) Plus 28,077,900 dollars, being the estimated increase in income from staff assessment approved by the Assembly in its resolution B above;
