Work programme on shipping: specific outputs and activities

Note by the UNCTAD secretariat

At its 4th meeting, on 6 November 1992, the Standing Committee on Developing Services Sectors (Shipping) decided "that the UNCTAD secretariat shall provide to the Trade and Development Board, through its President, before 31 January 1993, a list of specific outputs and activities, as well as the estimated dates of completion of work for each of the elements of the work programme."^{1/}

At the request of the President of the Trade and Development Board, the attached note is circulated to the States members of the Board.

Pursuant to the decision taken by the Standing Committee on Services (Shipping), the secretariat has prepared the following list of elements covering the period 1993 to 1995, taking into account the approval of the Standing Committee (Shipping) to hold its second and third sessions, respectively, in early 1994 and late 1995, the decision on the exact dates being referred to the Group on Calendar Matters.

Given that exact dates are not yet known and that other expected meetings have not yet been discussed and approved, information can only be provided on a quarterly basis for reference, but it should be noted that sessional documents should be submitted 3 months prior to any meeting.
