GENERALIZED SYSTEM OF PREFERENCES

Rules of origin

Note by the UNCTAD secretariat

This document contains relevant extracts from communications received from Angola, 1/ Bangladesh, 2/ Brazil, 3/ Cambodia, Panama 4/ and the Philippines. 5/

Angola

"With our best compliments, we have the honour to transmit the updated document containing the specimen signatures and stamp of the officials of the Ministry of Commerce and Tourism authorized to sign certificates of origin in (Form A) of our exports under the Generalized System of Preferences. 6/

"This notification accordingly supersedes the preceding notification."

Bangladesh

The UNCTAD secretariat has received specimen signatures of officials as well as specimens of the stamps utilized by the certifying authorities. 7/

Brazil

"... and has the honour to transmit a specimen of the new stamp to be used by Brazilian authorities in GSP Form A certificates of origin, which presents small changes in relation to the one presented in document TD/B/C.5/ORIGIN/43. 8/ The Permanent Mission of Brazil would be grateful if this information is circulated to the members of the Special Committee on Preferences.

Cambodia

"The competent Cambodian Certifying authority who signs the Certificate of Origin Form A is the Minister of Commerce or the chief official who is in charge of the GSP National Focal Point for Cambodia in the Ministry of Commerce." 9/

Panama

"... has the honour to transmit to you specimen stamps and the list of officials of the Panamanian Institute for Foreign Trade authorized to sign the certificates of origin (Form A) of Panamanian exports in conformity with the Generalized System of Preferences, with the request that it should be duly distributed to all persons concerned." 10/

Philippines

"... have the honour to transmit herewith a list of officers/personnel of the Bureau of Customs of the Philippines authorized to sign the GSP Certificate of Origin Form A in the ports of Manila, Cebu and Iloilo. 11/ Also shown on the enclosed list are the specimen signatures of these officers/personnel and the facsimile of the official seal of the Bureau of Customs used to authenticate the above-mentioned forms.

"It would be greatly appreciated if this information could be included in the Country Tabulated List of Authorized Signatories of Certifications of Origin for GSP purposes which are circulated to donor countries."



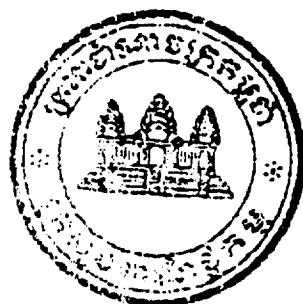
STANDARD STAMP USED FOR THE AUTHENTICATION OF THE
