II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Item 1: Election of officers

1. Under rule 64, paragraph 3, of the rules of procedure of the Trade and Development Board, each subsidiary organ of the Board shall elect its own officers. In accordance with the cycle of rotation for the election of the Chairman and Vice-Chairman-cum-Rapporteur of the Working Party, the Chairman of the Working Party at its twenty-fourth session (the third of a seven-session cycle) shall be a representative of one of the States members in list C (Latin America) and the Vice-Chairman-cum-Rapporteur a representative of one of the States members in list B.

Item 2: Adoption of the agenda and organization of work

- 2. The provisional agenda for the twenty-fourth session of the Working Party, as reproduced in section I above, was approved by the Working Party at its twenty-third session in June 1994.
- 3. In deciding upon the organization of work, the Working Party may wish to consider the suggestions contained in the tentative timetable annexed to the present document.

Item 3: Review of the technical cooperation activities of UNCTAD and their financing

- 4. Pursuant to paragraph 11(a) of Conference resolution 114(V), paragraph 11(b) of Board resolution 231 (XXII) and the recommendations adopted by the Working Party at its previous sessions, the Working Party will examine, at its twenty-fourth session, the technical cooperation activities of UNCTAD and their financing on the basis of a report prepared by the UNCTAD secretariat describing activities carried out in 1992 and 1993 (TD/B/WP/84 and Add.1).
- 5. The report begins with a summary that highlights the main features of UNCTAD's technical cooperation during the period 1992-1993. Part I comments on general trends in the source and use of technical cooperation funds. Part II reviews activities by programme area, organized according to the structure of the secretariat during this period. Part III addresses recent developments in UNCTAD's technical cooperation, including cooperation with other organizations, evaluation of projects and programmes, and the mobilization of resources, and information on recent General Assembly resolutions on operational activities that have a bearing on UNCTAD's technical cooperation.
- 6. The main report is accompanied by a detailed statistical annex listing all projects in operation during the reporting period, together with information on project expenditure, Trust Fund contributions and experts/consultants.

Item 4: Report by the Secretary-General of UNCTAD on the work of the secretariat on programme evaluation

7. The UNCTAD secretariat will report orally to the Working Party on developments in this regard.

Item 5: Report by the Secretary-General of UNCTAD on economies as well as on the redeployment of resources

8. In paragraph 4 of the agreed conclusions adopted at its ninth session, the Working Party invited the Secretary-General of UNCTAD, inter alia, to keep the Working Party informed on economies, as well as on redeployment of resources, including staff redeployment, that will be necessary to implement adequately the work programme deriving from relevant resolutions and decisions of intergovernmental bodies and conferences. The Officer-in-Charge of UNCTAD will report orally to the Working Party on any further developments in this regard.

Item 6: Provisional agenda for the twenty-fifth session of the Working Party

9. The UNCTAD secretariat will submit to the Working Party for its consideration a draft provisional agenda for its twenty-fifth session.
