PROTOCOL

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF ANGOLA AND THE AZERBAIJANI REPUBLIC

The Republic of Angola and the Azerbaijani Republic,

Guided by the mutual willingness to develop relations of friendship and cooperation in the political, economic, cultural, humanitarian and other fields,

Having the intention of developing these relations on the basis of the purposes and norms of the Charter of the United Nations and other norms of International Law,

Have agreed to establish diplomatic relations at Ambassadorial level as of the date of the signing of this Protocol, based on the provision of the Vienna Convention on Diplomatic Relations of 1961,

The Republic of Angola and the Azerbaijani Republic convinced that the establishment of diplomatic relations corresponds to the national interests of both States, and will contribute to the consolidation of cooperation and peace in the world.

Done in the City of New York on 1 December 1994, in duplicate in English and Portuguese languages, all texts being equally authentic.
