**PROTOCOL
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE KINGDOM OF NEPAL
AND
THE REPUBLIC OF GUYANA**

The Kingdom of Nepal and the Republic of Guyana, desiring to further promote relations of friendship and co-operation, have agreed to establish diplomatic relations at Ambassadorial level as of signature of this Protocol in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961 and on the basis of the principles enshrined in the Charter of the United Nations.

Done at New York, on June 22, 1994, in duplicate in English.
