I. CALENDAR OF CONFERENCES AND MEETINGS

A. Matters related to, and inter-sessional departures from, the approved calendar for 1994

Introduction and overview

1. In its resolution 48/222 A of 23 December 1993, the General Assembly approved the draft calendar of conferences and meetings for the biennium 1994-1995 as set forth in annex I to the report of the Committee on Conferences to the Assembly at its forty-eighth session 1/ and amended by subsequent decisions taken by the Assembly during that session.
2. At its organizational session (363rd meeting), on 8 April 1994, the Committee agreed that proposed changes to the calendar that did not have programme budget implications could be dealt with by the Secretariat in consultation with the Bureau of the Committee. The Committee was advised of a number of such changes during the course of 1994.
3. In addition, by written communication from the Secretary, the Committee was advised of requests for changes or additions to the approved calendar of conferences for 1994. The nature of the requests and the action taken by the Committee are described below.

Conclusions and recommendations

4. The Committee emphasized the need for bodies, as far as possible, to reduce the amount of conference time they requested in view of the limited resources of the Office of Conference and Support Services.

5. It also drew attention to the exceptional nature of the departures from the approved calendar.

6. The Committee decided that requests for inter-sessional departures submitted to the Committee should, in future, be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.

B. Adoption of the draft revised calendar of conferences and meetings for 1995

Introduction and overview

7. At its 366th, 367th and 373rd meetings, on 22, 23 and 26 August 1994, respectively, the Committee on Conferences reviewed three documents relating to the draft revised calendar of conferences and meetings for 1995: the draft revised calendar of conferences and meetings for 1995, the consolidated statement of scheduled special conferences for 1995 (A/C.5/49/2) and the letter dated 8 April 1994 from the Permanent Representative of Pakistan to the United Nations addressed to the Chairman of the Committee on Conferences (A/AC.172/156).

Discussion

8. Clarification was sought and received from the Secretariat regarding various items and aspects of the draft revised calendar of conferences and meetings for 1995.

9. It was noted that some bodies, such as the Group of Three established under the International Convention on the Suppression and Punishment of the Crime of Apartheid of the Commission on Human Rights, and the Commission against Apartheid in Sports, were included in the calendar even though it would appear that their mandates had terminated in conformity with General Assembly resolution 48/258 of 23 June 1994. The Secretariat explained that, in the light of the legal status of those bodies (treaty bodies), it was incumbent upon them to terminate their mandates.

10. Clarification was also sought and received from the Secretariat regarding the need for and usefulness of the consolidated statement of scheduled special conferences for 1995 (A/C.5/49/2).

11. It was felt that the information on financial and human resources devoted to those conferences should be presented in greater detail so as to include, in addition to the costs of plenary conferences, all resources allocated to the different preparatory committees, working groups, expert groups and ad hoc secretariats. This information would be helpful in enabling delegations to take decisions on financial matters and to make economies.

12. Clarification was sought and received from the Secretariat regarding the policy for establishing official holidays at the various duty stations. The

Secretariat explained that the authority to designate official holidays at each duty station rested with the Secretary-General and that the procedure was guided by three considerations: their number should not exceed nine days per year; they should coincide with public holidays at each duty station that were also school holidays; and they should be staggered to fall roughly every two months.

13. An extensive debate took place in the Committee on that issue. A view was expressed that the competence of the Secretary-General with respect to the designation of official holidays was not in contradiction with the competence of Member States to whom it fell to approve, after possible modifications, rules relating to the conditions of service of United Nations officials, including the establishment of official holidays.

14. A view was also expressed that the Committee, as the advisory body to the General Assembly dealing with the calendar of conferences and meetings, was within its competence to recommend not to hold meetings on Id al-Fitr and Id al-Adha, referred to in the letter from the Permanent Representative of Pakistan to the United Nations (A/AC.172/156), as many Member States would be unable to participate. It was also proposed that consideration should be given to including them as official holidays of the United Nations.

15. Other views were expressed that the appropriate forum to propose any change in official holidays would be the General Assembly at its forty-ninth or fifty-first sessions, during the year in which personnel issues and staff rules and regulations were reviewed. Therefore, it was further expressed that the Committee was not in a position to make recommendations to the General Assembly or its United Nations bodies in regard to the observance of holidays in the calendar which were not yet recognized as official.

16. It was noted that the chairmen of committees were usually responsive to the requests of the member States of the Organization of the Islamic Conference not to hold meetings on those two holidays when many delegations were unable to participate, and that they endeavoured to adjust the schedule of work of the Committee accordingly.

17. A proposal was made that the matter should be referred to the General Assembly under the agenda item entitled "Personnel questions".

Conclusions and recommendations

18. The Committee recommended to the General Assembly that it should:

- (a) Adopt the draft revised calendar of conferences and meetings for 1995;
- (b) Authorize the Committee to make adjustments to the calendar of conferences and meetings for 1995 that might become necessary as a result of action and decisions taken by the General Assembly at its forty-ninth session;
- (c) Invite the competent legislative organs to disband all bodies dealing with apartheid;
- (d) Invite United Nations bodies to avoid holding meetings on 2 March and 9 May 1995, and also invite the Secretariat, when drafting the proposed calendar of conferences and meetings for 1996-1997, to take into account the same concerns expressed by some Member States.

19. The Committee requested the Secretary-General to submit to the General Assembly at its forty-ninth session a consolidated statement relating to the number and costs of special conferences scheduled for 1995.

20. The Committee also requested the Secretariat to submit to the General Assembly at its fiftieth session, through the Committee on Conferences, a synoptic table by sector of meetings held during the bienniums 1992-1993 and 1994-1995 (using projections for the second half of 1995), including the notional cost of conference services provided, as well as a breakdown of meeting services and documentation costs.

C. Improved utilization of conference-servicing resources

1. Meeting statistics of United Nations organs

Introduction and overview

21. Since 1983, the Committee on Conferences has studied a series of reports showing the meeting statistics of a number of United Nations organs in New York, Geneva and Vienna. At its 348th meeting, on 18 May 1993, the Committee agreed to continue with the experimental methodology in use since 1991, and requested the Secretariat to expand the information presented to include analyses of trends perceived and capacity utilization figures.

22. In view of its earlier decisions and the requests of the General Assembly contained in paragraph 7 of its resolution 48/222 A, the Committee reviewed two reports at its 368th and 369th meetings, on 23 and 24 August 1994, one compiled in accordance with the approved methodology (A/AC.172/157 and Corr.1) and one including analyses of trends and figures on the utilization of conference services.

23. Moreover, in accordance with the provisions of paragraph 8 of General Assembly resolution 48/222 A, the Chairman of the Committee held consultations with the chairmen of organs concerned, where the utilization factor was lower than the established benchmark figure applicable for the last three sessions. At the same meetings, the Committee considered a report by the Secretariat on the results of those consultations.

Discussion

24. It was noted that the core sample of bodies in document A/AC.172/157 and Corr.1 had been expanded and that the overall and average utilization factors had increased considerably in 1993.

25. It was also felt that the emerging trend of late starts of meetings at times led to the need for additional meetings, which resulted in an increased workload for Conference Services.

26. It was also noted that Conference Services recognized that, while indicators for analysing capacity utilization of interpretation were available, no such indicators existed with regard to documentation-processing capacity, in particular, as there was no assessment of demand for documents to be processed.

Conclusions and recommendations

27. The Committee welcomed the improved overall and average utilization factors for the core sample of bodies.

28. It requested the Secretariat to expand the core sample in the statistical analysis to include the Main Committees of the General Assembly and the Advisory Committee on Administrative and Budgetary Questions.

29. It also requested the Secretariat to include in future reports figures on the capacity utilization of conference services (for interpretation and documentation) in New York, Geneva and Vienna.

30. In addition, the Committee requested its Chairman to consult on its behalf with the chairmen of bodies that had consistently utilized less than the applicable benchmark figure (75 per cent for calendar years 1983 to 1993 and 80 per cent for calendar year 1994) of their allocated resources for the last three sessions, with a view to making appropriate recommendations in order to achieve the optimum utilization of conference-servicing resources.

31. The Committee reiterated its recommendation to the General Assembly that it should urge those bodies whose utilization factor was below the benchmark figure applicable for the last three sessions to review and consider reducing the amount of conference-servicing resources requested.

2. Conference services at Vienna

Introduction and overview

32. At its 363rd meeting, on 8 April 1994, the Committee on Conferences decided to consider the question of conference services at Vienna. At its 366th meeting, on 22 August 1994, in the context of paragraph 14 of General Assembly resolution 48/222, the Committee considered a note by the Secretariat on the question.

Discussion

33. The Secretariat confirmed the progress made in the establishment of unified United Nations conference services, which would become a reality as of 1 January 1995, the modalities of which had been the subject of a draft agreement. On the basis of that agreement, the Secretary-General would submit to the General Assembly at its forty-ninth session the revised budget estimates under chapter 25 E (Conference and library services, Vienna) of the programme budget for the biennium 1994-1995. It was stipulated that the establishment of such unified conference services would not entail additional expenditures for Member States.

Conclusions and recommendations

34. The Committee took note of the note by the Secretariat.

3. Legal basis and experience of all subsidiary bodies that meet away from their established headquarters

Introduction and overview

35. In paragraph 20 of its resolution 48/222 A, the General Assembly requested the Secretary-General to review the legal basis and experience of all subsidiary bodies that meet away from their established headquarters, thus constituting a departure from Assembly resolution 40/243, and to report thereon to the Assembly at its forty-ninth session through the Committee on Conferences.

36. At its 366th meeting, on 22 August 1994, the Committee considered the report of the Secretary-General on the matter (A/49/212).

Discussion

37. It was noted that certain subsidiary bodies that met away from their established headquarters had reported decided advantages in doing so, in particular the savings involved for the Organization. It was stated that, as the purpose of the established headquarters rule was to reduce expenditure, it would be useful to have data on the costs of meeting away.

38. The view was expressed that, as the provisions of General Assembly resolution 40/243 of 18 December 1985 constituted a rule, exceptions in addition to those listed in section I, paragraph 4 (a) to (i) of that resolution should be kept to a minimum. The Assembly should assume a pragmatic position in its consideration of the matter, including the question of whether a waiver should continue to be granted to the functional commissions of the Economic and Social Council, which had not exercised their right to meet away since the resolution was adopted.

39. The view was also expressed that the rule should be strictly complied with and that no further exceptions should be granted. Moreover, bodies that had not exercised their right to meet away should no longer be entitled to do so.

40. The Secretariat provided clarification of various elements of the report.

Conclusions and recommendations

41. The Committee expressed its appreciation for the quality of the report of the Secretary-General (A/49/212).

42. The Committee recommended that the General Assembly should:

(a) Discontinue the waiver of the Legal Subcommittee of the Committee on the Peaceful Uses of Outer Space, in the light of the transfer of that body to Vienna and the decision of that body to hold its meetings at Vienna in future;

(b) Reformulate the waiver granted to the Economic and Social Council, in the light of the measure adopted by the Assembly in paragraph 5 (c) of the annex to its resolution 45/264 of 13 May 1991, whereby one substantive session of the Council of four to five weeks' duration took place in alternate years in New York and Geneva between May and July;

(c) Discontinue the waiver granted to the functional commissions of the Council, as they had not exercised their right to meet away since 1985.

43. The Committee further recommended that the General Assembly, in the light of the advice of the Office of Conference and Support Services, when considering exceptions under resolution 40/243, should take into account the financial implications of the waiver, its effect on the work of the organs involved, as well as the volume of work at the headquarters of the organ involved and at Headquarters (New York). To that end, the Committee recommended that the Assembly should consult closely with the organs that requested waivers to resolution 40/243.

D. Requests for exceptions to section I, paragraph 7, of General Assembly resolution 40/243

Introduction and overview

44. At its 365th meeting, on 22 August 1994, the Committee on Conferences considered a note by the Secretariat containing requests from subsidiary bodies for exceptions to be made to section I, paragraph 7, of General Assembly resolution 40/243, which stipulated that no subsidiary organ of the Assembly might meet at United Nations Headquarters during a regular session of the Assembly unless explicitly authorized by the Assembly.

45. In accordance with the procedure established by the Committee, the requests included explanations as to (a) why the bodies wished to meet; (b) why they had not completed their work by the deadline of 1 September laid down in section I, paragraph 6, of Assembly resolution 40/243; (c) why it was necessary to meet during the Assembly session; and (d) how many meetings would be required. Statistical information was also provided on the number of meetings, if any, the bodies concerned had held during the forty-eighth session of the Assembly and the efficiency with which they had utilized the resources made available to them.

Conclusions and recommendations

46. The Committee recommended to the General Assembly that it should explicitly authorize the following bodies to meet in New York during the forty-ninth session of the General Assembly, on the understanding that meetings would have to be accommodated as facilities and services became available so that the activities of the Assembly itself were not adversely affected: Committee on Relations with the Host Country; Committee on the Exercise of the Inalienable Rights of the Palestinian People; Advisory Committee on the United Nations Educational and Training Programme for Southern Africa; Preparatory Committee for the Fiftieth Anniversary of the United Nations; Working Group on the Financing of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA); Executive Board of the United Nations Children's Fund (UNICEF); Executive Board of the United Nations Development Programme (UNDP)/United Nations Population Fund (UNFPA); and Committee on Conferences.

II. CONTROL AND LIMITATION OF DOCUMENTATION

A. Provision of written meeting records to subsidiary organs of the General Assembly

Introduction and overview

47. In paragraph 16 of its resolution 47/202 B of 22 December 1992, the General Assembly decided to undertake, at its forty-ninth session, a comprehensive review of, *inter alia*, the need for and usefulness and timely issuance of verbatim and summary records, on the basis of a report submitted by the Secretary-General through the Committee on Conferences and the Advisory Committee on Administrative and Budgetary Questions. Subsequently, in paragraph 3 of its resolution 48/222 B, the Assembly encouraged all bodies currently entitled to meeting records to review the need for such records, particularly verbatim records, and to communicate their recommendations to the Assembly at its forty-ninth session.

48. In the context of the review of the proposed programme budget for the biennium 1994-1995, the Committee on Conferences requested the Secretariat to consider the possibility of transferring to the Office of Conference and Support Services the staff specialized in the drafting of press releases, so that they could prepare summary records also, and to communicate the results of the study to the Committee and to the General Assembly at its forty-ninth session.

49. At its 365th, 367th and 368th meetings, held on 22 and 23 August 1994, the Committee considered the report of the Secretary-General on this question (A/49/276 and Add.1 and 2), as well as a note by the Secretariat on the same subject.

Discussion

50. It was recalled that all decisions concerning a limitation or reduction in the provision of written meeting records must be taken by the General Assembly; the Secretary-General did not have the power to take decisions in the matter. The provision of verbatim records in the six official languages, at a notional cost of \$16,600 per record, was more costly than the provision of summary records, also in the six languages, the notional unit cost of which was \$10,200. Those costs included time devoted by permanent staff to drafting, translating and text processing, and reproduction supplies. Nevertheless, the Secretariat noted that the replacement of verbatim records by summary records could raise serious problems. Verbatim records were provided by specialized teams, while summary records were provided by translator/précis-writers, whose duties also included translation. If the provision of verbatim records was reduced, the capacity of the translation services would have to be increased; the translation of summary records already represented 12 to 13 per cent of their total translation workload. In fact, the summary record workload had already exceeded the capacity of the translation services, so that it had been necessary, in view of the rule on simultaneous distribution, to delay the issuance of summary records for up to six months or even longer. It would be difficult to increase the workload further without increasing the capacity of the translation services.

Conclusions and recommendations

51. The Committee noted with satisfaction that the Executive Boards of UNDP, UNFPA and UNICEF had decided to dispense with summary records.

52. The Committee agreed on the need for and desirability of verbatim and summary records for some bodies of a political or legal nature. Nevertheless, there was a need to review procedures and to streamline the provision of meeting records.

53. In order to encourage bodies entitled to meeting records to review their need for such records, the Committee recommended that the General Assembly should invite the bodies established by the Charter of the United Nations to review their entitlement to meeting records and, in the case of treaty bodies authorized to establish their own practice in the matter, appeal to them to review such a need.

54. The Committee decided to request the President of the General Assembly to send a letter to the chairmen of some bodies, requesting them to review their need for meeting records. In addition, it recommended that meeting records should be provided as follows:

(a) Bodies continuing to receive verbatim records:

55. The Committee expressed regret that the request of the General Assembly to establish time-limits had not been met. With a view to shortening summary records, the Committee recommended that the General Assembly should again

request the chairmen of the relevant organs and subsidiary bodies of the Assembly to propose to Member States, at the beginning of each session, the adoption of time-limits for speakers, as it had done in paragraph 11 of resolution 48/222 A.

56. The Committee stressed the importance of summary records for the work of delegations and recommended that their timely issuance should be improved. With regard to the drafting of press releases and the drafting of summary records, the Committee endorsed the recommendation of the Secretariat in favour of maintaining the current system, under which the two types of documents were provided by different staff, inasmuch as such documents had different objectives and the staff members concerned performed different duties.

B. Implementation of the rules and regulations on control and limitation of documentation: compliance with the six-week rule for the issuance of pre-session documentation

Introduction and overview

57. In paragraph 9 of its resolution 47/202 B, the General Assembly requested the Secretary-General to review all of the factors involved in the timely issuance of pre-session documentation, including the quality and timeliness of submission to Conference Services, and to report thereon to the Assembly at its forty-ninth session through the Committee on Conferences.

58. At its 347th and 350th meetings, on 18 and 19 May 1993, the Committee considered an interim report on the matter, on the understanding that additional information would be submitted to it at its substantive session of 1994.

59. In addition, in paragraph 2 of its resolution 48/222 B, the General Assembly requested the Secretary-General to submit to the Assembly at its forty-ninth session, through the Committee, an analytical report on the factors that contribute to the late issuance and distribution of documentation, including the increase in the workload of Conference Services, the level of staffing, workload standards, the late submission of documents by departments and the effects of the introduction of technological innovations in the Office.

60. At its 370th and 371st meetings, on 24 and 25 August 1994, the Committee considered a conference room paper which was a provisional version of the report to be submitted in final form to the General Assembly at its forty-ninth session and which supplemented the interim report of 1993 mentioned above.

Discussion

61. It was recognized that the documentation crisis was a result, in part, of non-compliance with the six-week rule for the issuance of pre-session documentation. For several years, the demand for documents had exceeded the capacity of the various services, including at the research and drafting stage, so much so that the author departments themselves were having great difficulty in complying with the six-week rule. As a result in many cases Conference Services was having to give priority to documents that were submitted late, which in a way meant that departments which did comply with the 10-week rule were being penalized. It was felt that the necessary human and technological resources would have to be increased in order to cope with the demand. In that connection, it was felt that it was not desirable to go ahead with the proposed

elimination of 19 posts in Conference Services. Technological innovations had made it possible to increase the productivity of Conference Services, but the quality of documents had not improved since, at the level of the translation services, work was increasingly self-revised (more than half of the output) whereas, previously, revision had been the main means of ensuring quality control.

62. According to the Secretariat, one solution might be to abandon the 10-week and 6-week rule and have a uniform 2-week processing period instead, whatever the date of submission of documents to Conference Services. In that case, processing of other documents would not be interrupted, but it would in any event be necessary to continue making exceptions, for example, for the Security Council.

63. In order to encourage dialogue and cooperation between Member States, and particularly between the Committee on Conferences, the Office of Conference and Support Services and the substantive author departments, it was suggested that a tripartite working group be established to review questions of documentation and to try to seek practical solutions to the difficulties encountered. It was pointed out that there already were two special interdepartmental teams responsible for working on this situation and that it would be better to use existing structures, although exchanges of views could take place informally.

64. The Committee recommended that a constructive dialogue should take place between the Secretariat, Member States and all parties concerned on questions of documentation. The Committee also recommended that better coordination on documentation should be introduced, in particular, between the Office of Conference and Support Services and the substantive author departments.

65. The Committee was of the view that, given the considerable increase in documentation, which was due largely to the expanded activities of the Security Council, it was necessary to provide the Office of Conference and Support Services with the human, financial and material resources needed to cope with that increase, *inter alia*, by investing in new technological applications. In that regard, the Committee recommended, in particular, that the start-up programme of the optical disk system should be accelerated. The Committee stated that it was concerned about the proposals to reduce staff in the Office of Conference and Support Services, in particular, in translation. Given the increase in the workload in the Office, and the deterioration in the quality of the translation of documents submitted to Member States, as well as the late submission of documentation, the Committee recommended that the Secretariat should submit proposals with a view to ensuring the availability of adequate human and financial resources to the Office of Conference and Support Services to the General Assembly at its forty-ninth session.

66. The Committee praised the initiatives taken by the Executive Board of UNDP and the Economic and Social Council to control and limit documentation. It recommended that the General Assembly should adopt the measures for limiting documentation for the Council and its subsidiary bodies as enumerated in document E/1994/L.41. It also recommended that other bodies should follow their example.

67. While recognizing that the strict application of the rule authorizing the Office of Conference and Support Services to reject for processing any document not submitted within the prescribed time-limits could result in disruption in the functioning of the Organization, the Committee wished to recall that it was

the responsibility of the Secretary-General to enforce administrative instruction ST/AI/189/Add.23 on the timely submission and length of documents.

III. REVIEW OF THE PROGRAMME PERFORMANCE OF THE UNITED NATIONS FOR
THE BIENNIUM 1992-1993: SECTION 41 J, CONFERENCE SERVICES

Introduction and overview

68. In its resolution 39/238 of 18 December 1984, the General Assembly approved the recommendations of the Committee for Programme and Coordination, 2/ including the recommendation that relevant intergovernmental bodies should review the programme performance report.

69. At its 365th and 366th meetings, on 22 August 1994, the Committee on Conferences considered the report of the Secretary-General on programme performance of the United Nations for the biennium 1992-1993 (A/49/135 and Add.1) concerning section 41 J (Office of Conferences Services, New York).

Discussion

70. Regrets were expressed at the fact that the programme performance report did not provide a qualitative assessment of programme performance during the biennium (A/49/135, para. 38). Deep concern was expressed at the fact that total output/services (over 180 million words) provided by the translation services during the period 1992-1993 were substantially higher than the 147.5 million words which had been forecast in the programme budget.

71. The Secretariat explained that the figures on the volume of work done, in the form of output/services, did not give an accurate picture of the workload of Conference Services, in particular the translation services, since there was a need also to take into account the unsatisfied demand for such services. In that context, Conference Services had coped with the large increase in workload, stemming in particular from the Security Council and its subsidiary organs, by increasing productivity through technological innovations, but also by resorting to self-revision and by delaying the issue of certain documents which had resulted in a regrettable decline in the quality of services provided, in particular, in documentation-processing and translation. In that context, the soundness of the Secretary-General's proposal to reduce staff in the Translation Division was questioned by delegations.

Conclusions and recommendations

72. Bearing in mind the report of the Secretary-General (A/49/135 and Add.1), the Committee recommended to the General Assembly that it should pay the utmost attention to the improvement in the quality of conference services, particularly documentation-processing.

IV. COMPREHENSIVE STUDY ON CONFERENCE SERVICES

Introduction and overview

73. In section II, paragraph 42, of its resolution 48/228 of 23 December 1993, the General Assembly requested the Secretary-General to submit to it at its forty-ninth session a comprehensive study on the organization, management and human resources requirements for the provision of adequate conference services as a basis for the consideration of his proposals for the regular budget for the biennium 1996-1997, and to provide Member States with previous studies on the matter that were carried out during the biennium 1992-1993.

74. At its 369th-373rd meetings, from 24 to 26 August 1994, the Committee on Conferences reviewed an interim report on the comprehensive study on the matter.

Discussion

75. The view was expressed that the study was well structured and provided the main areas for inclusion in the final report to be submitted to the General Assembly at its forty-ninth session. It would be useful if the information were supplemented by graphs.

76. The view was also expressed that the study as presented contained terminology that was not in keeping with other United Nations documents and lacked sufficient concrete conclusions and recommendations.

77. Clarification was sought and received from the Secretariat regarding various aspects of the study. In reply to queries regarding the trade-offs that might be necessary when seeking an optimal balance among quality, timeliness and cost-efficiency, the Secretariat noted that, while compromises were not a deliberate policy of Conference Services, they were a daily necessity.

78. In reply to a query concerning proposals for improvement, the representative of the Secretariat noted that the account manager function would not entail staffing implications. Rather than duplicating the work of the committee secretaries, account managers would complement their work, relying on committee secretaries for an assessment of the requirements of Member States and the schedule of provision of documents by author departments. In turn, account managers would provide information to committee secretaries concerning all aspects of conference-servicing for their bodies. That concept was related to a perceived need to strengthen the advance planning function of Conference Services, particularly in the documentation area. The account manager would track the development of a document from the initial request, and work with committee secretaries to resolve problems that might arise at any stage of document production.

79. In reply to a query concerning the performance improvement function, the representative of the Secretariat noted that the Secretariat was proposing to give a formal structure to the concern about performance improvement by establishing it as a distinct function, that is, by developing networks of staff members throughout Conference Services who would meet regularly to coordinate improvement projects in their units and report to the Director of Conference Services.

80. In reply to a query concerning performance measurements, the representative of the Secretariat stated that until now, performance measurements had been purely quantitative. Conference Services would like to develop performance indicators for internal and external reporting that would cover the criteria of timeliness, quality and cost-efficiency referred to in paragraph 6 of the interim report.

81. In reply to a query concerning cost accounting, the representative of the Secretariat stated that the effective management of conference services resources required an active knowledge of their costs. Consequently, Conference Services had proposed a detailed cost-accounting study so as not to rely on hypothetical costs for planning and managing of resources. Such a system would enable Conference Services: to manage resources more effectively; to decide whether it was more cost-efficient to use temporary staff or contractual services; and to respond more quickly to delegations' queries concerning financial implications and actual costs of conference services.

82. With regard to the technological innovations programme in Conference Services, it was stated that the optical disk system on which United Nations documents were currently being stored should be expanded at an early date to provide access to all interested missions in New York and Geneva. The Committee was informed that the capacity of the optical disk system was being expanded under provisions contained in the programme budget for 1994-1995, and that missions wishing to have access to it would be assisted by the Secretariat.

83. In reply to a query concerning dynamic staffing practices that would allow staff to be redeployed where needed, the representative of the Secretariat indicated that in the past some consideration had been given to the possibility of making language staff more interchangeable, which would be studied again in the light of current recruitment and placement rules and practices.

84. In reply to a query concerning demand forecasting, the representative of the Secretariat explained that up to now meetings and documentation workload estimates had been based on output statistics, which reflected capacity rather than demand at a given time. In order to manage conference services resources more effectively, estimates of real workload were necessary.

85. The delegation of Egypt made a detailed proposal regarding the improvement of the Arabic translation services (see annex II).

Conclusions and recommendations

86. The Committee noted with regret that the report had not been finalized and expected that the final report would be produced in time for due consideration by the Committee before submission to the General Assembly at its forty-ninth session.

87. The Committee was of the view that the final report on the comprehensive study on conference services should:

(a) Incorporate terminology and definitions compatible with other United Nations documents;

(b) Have a structure that followed the request in the mandating resolution and clarify the data contained therein with graphic presentations;

(c) Recommend performance indicators that would include measurements of quality, timeliness, accountability and cost-efficiency of conference services and develop a cost-accounting system that would provide better information on the real costs of conference servicing. In that regard, the Committee wished to recall that it had already recommended that some of those measures should be taken and that recommendations along those lines had been approved by the General Assembly in its resolution 48/222 A. It expressed its deep concern that the Secretariat had not met that request;

(d) Contain specific proposals to address documentation problems in order to achieve significant improvement in terms of quality, timeliness of submission and cost-efficiency;

(e) Contain a detailed analysis of staff and other resource requirements for the provision of adequate conference services, including their training, especially for translators;

(f) Consider dynamic staffing practices, such as cross-training and hiring of personnel with broader skills, that would facilitate redeployment;

(g) Propose improved indicators to estimate real demand for conference services.

88. The Committee was not convinced of the need to hire external consultants for the further stages of the study, as the Secretariat had sufficient in-house expertise to deal with the matter. The Committee also wished to emphasize that the use of adequate internal expertise would be more cost-efficient. Therefore, the Committee recommended that further stages of the study should be carried out through the use of internal expertise.

89. The Committee stressed the equal importance of quality, timeliness and cost-efficiency and appreciated that the Secretariat recognized that an optimum should be achieved in all three areas.

90. The Committee trusted that the Secretariat, in consultation with interested delegations, would follow up on the proposal made by the delegation of Egypt regarding the improvement of the Arabic translation services. The Committee decided to keep the matter under review.

V. ORGANIZATIONAL MATTERS

A. Membership

91. In its resolution 43/222 B, the General Assembly decided to retain the Committee on Conferences as a permanent subsidiary organ. Pursuant to that resolution, the Committee in 1994 was composed of the following Member States: Austria, Chile, Egypt, Fiji, France, Gabon, Grenada, Honduras, Hungary, Iran (Islamic Republic of), Jamaica, Japan, Jordan, Morocco, Mozambique, Niger, Pakistan, Russian Federation, Senegal, Turkey and United States of America.

B. Officers

92. The Committee elected the following officers to serve in 1994:

Chairman: Ms. Maria Rotheiser (Austria)

Vice-Chairmen: Mr. Fernando Varela (Chile)
Mr. Csaba Sz. Nagy (Hungary)
Mr. Noor Muhammad Jadmani (Pakistan)

93. At its organizational session for 1994 (363rd meeting), on 8 April 1994, the Committee agreed in principle that the Chairman would undertake informal consultations with a view to determining the composition of the Committee's Bureau in 1995.

C. Organization of work

94. At its 363rd meeting, on 8 April 1994, the Committee agreed to meet as required to take up matters related to the calendar of conferences and its implementation, in particular the consideration of inter-sessional departures from the approved calendar. At the same meeting, the Committee requested the Secretariat to submit a draft biennial agenda for 1995-1996 at the organizational session to be held early in 1995. The Committee convened its resumed organizational session (364th meeting) on 31 May 1994 and its substantive session from 22 to 31 August 1994 (365th to 377th meetings).

95. The Committee expressed regret at the delayed submission of some of its documents, which were often presented in provisional form. The Committee noted that it was experiencing the same difficulties as the Organization as a whole with regard to documentation.

D. Programme of work

96. At its organizational session for 1993, on 2 March 1993, the Committee requested the Secretariat to submit to it, at its organizational session for 1994, a draft biennial agenda for 1994-1995, which was subsequently issued in document A/AC.172/154 and adopted by the Committee.

97. The Director of Conference Services and the Assistant Secretary-General, Conference and Support Services, respectively, addressed the Committee at the opening of its organizational and substantive sessions.

VI. WORK OF THE COMMITTEE DURING THE FORTY-EIGHTH SESSION
OF THE GENERAL ASSEMBLY, FROM 21 SEPTEMBER TO
23 DECEMBER 1993

98. No meetings were held by the Committee on Conferences during the forty-eighth session of the General Assembly. However, the Committee was seized with the following request:

The purpose of the proposals submitted by the delegation of Egypt is, on the one hand, to eliminate the deficiencies which adversely affect the quality of Arabic translation and, on the other to make use of the capacity available in the Arabic Translation Service by enabling all highly qualified personnel to demonstrate their creativity and to assume a more active and more useful role for the benefit of all users of Arabic documentation.

2. The proposed plan consists of two phases: in the first we would pinpoint the deficiencies, and put an end to the practice of translating literally into Arabic from foreign languages, which has caused us many problems, and in the second we would "Arabize" United Nations documentation in order to make it really useful not only to representatives of Arab Governments, but also to all those who are interested in the United Nations (universities, institutions and non-governmental organizations, etc.).

3. Phase I would start with the opening of the forty-ninth session of the General Assembly and continue until the end of 1995, so as to coincide with the celebration of the fiftieth anniversary of the United Nations.

4. The aim would be to enhance the quality of service provided to users of documentation by making the following improvements:

(a) Abolishing what is called self-revision, which has proved ineffective;

(b) Abolishing the practice of dividing documents among several translators, so as to avoid inconsistency. Where this is not possible, the translation should be revised by one reviser so as to ensure consistency of terms and meanings;

(c) No document should be issued before ensuring that the same terminology has been used throughout the document;

(d) Abandoning the idea that it was necessary to stay close to the original text and trying instead to render the essence of the text while preserving the spirit of the Arabic language (as French translators do);

(e) Desisting from the attempt to find a single Arabic equivalent for each foreign word, and using circumlocutions instead while respecting Arabic style as much as possible;

(f) Reviewing all terms alien to the Arabic language that are currently used at the United Nations but that are not found in dictionaries;

(g) Putting an end to the practice of building sentences in Arabic based on the structure of the original text, which makes the Arabic clumsy, complicated and unintelligible, and using nominal clauses whenever possible.

5. In short, the aim is to stop translating literally into Arabic from other languages, and to do what French translators do, namely, translate the meaning of the original text and make the French text consistent with the spirit and structure of the French language.

6. The timing of phase II would depend on what can be accomplished in 1995. The purpose of this phase is to carry out a process of "Arabization" of United Nations documents so as to make them useful to all Arab countries and to users at all levels (official and private), and so that the reader does not recognize them as translations. These documents will then be a source of enrichment for Arab culture and will communicate the message of the United Nations clearly to all Arab societies. The details of phase II can be studied towards the end of phase I, in other words, at the Committee's substantive session of 1995.

7. Lastly, the success of the proposed plan will depend on the constructive cooperation of all relevant members of the Arabic Translation Service and their willingness to respond quickly to this challenge, namely the general promotion and enhancement of Arabic within the United Nations.
