We have the honour to inform Your Excellency that the Government of the Republic of Trinidad and Tobago and the Government of the Republic of Guatemala, in order to ensure greater development of friendly relations between them, to promote cooperation in areas of common interest for the benefit of the two countries, to act jointly in support of peace in the international community in accordance with the purposes and principles established in the United Nations Charter and based on the relevant provisions of the Vienna Convention that regulate diplomatic relations between States, have decided to establish, as from 25th May, 1994, diplomatic relations between them at Ambassadorial level.

We have the honour, further, to request that this information be transmitted to the Permanent Missions of Member States of the United Nations.

We take this opportunity to renew to Your Excellency the assurances of our highest consideration.

**On the Establishment of Diplomatic Relations Between  
The Republic of Trinidad and Tobago and The Republic of Guatemala**

**The Republic of Trinidad and Tobago and the Republic of  
Guatemala,**

**Guided by the mutual desire to develop relations of friendship and  
cooperation in the political, economic, cultural and humanitarian fields,**

**Having the intention of developing these relations on the basis of  
the purposes and norms of the Charter of the United Nations and International  
Law,**

**Have agreed to establish diplomatic relations at Ambassadorial level  
as of the date of the signing of this Protocol, based on the Vienna Convention on  
Diplomatic Relations of 1961.**

**The Republic of Trinidad and Tobago and the Republic of  
Guatemala are convinced that the establishment of diplomatic relations corresponds  
to the national interests of both States, and will contribute to the consolidation of  
cooperation and peace in the world.**

**Signed in duplicate in the City of New York, on 25th May, 1994,  
in the English and Spanish languages, both texts being equally authentic.**

## PROTOCOLO

### Sobre el Establecimiento de Relaciones Diplomáticas entre la República de Guatemala y la República de Trinidad y Tobago

La República de Trinidad y Tobago y la República de Guatemala,

Guiadas por el deseo mutuo de desarrollar relaciones de amistad y cooperación en las áreas política, económica, cultural y humanitaria.

Teniendo la intención de desarrollar estas relaciones sobre la base de los principios y normas de la Carta de las Naciones Unidas y del Derecho Internacional.

Han acordado establecer relaciones diplomáticas a nivel de Embajadores, a partir de la fecha de la firma de este protocolo, basados en la Convención de Viena sobre Relaciones Diplomáticas de 1961.

La República de Guatemala y la República de Trinidad y Tobago están convencidas que el establecimiento de Relaciones Diplomáticas responde a los intereses nacionales de ambos Estados y contribuirá a la consolidación de la cooperación y la paz en el mundo.
