**PROTOCOL
ON THE
ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN**

THE REPUBLIC OF MAURITIUS

AND

THE KINGDOM OF CAMBODIA

The Republic of Mauritius and the Kingdom of Cambodia, following the mutual desire to develop friendship and cooperation in political, economic and cultural fields,

On the basis of the principles of mutual respect, territorial integrity and non-interference in each other's internal affairs as well as in accordance with the norms of international law and principles of the Charter of the United Nations,

Have agreed to establish diplomatic relations in accordance with the Vienna Convention on Diplomatic Relations of April 18, 1961.

The Republic of Mauritius and the Kingdom of Cambodia express their confidence that the establishment of diplomatic relations between the two countries meets their national interests and will promote the development of international and regional cooperation.

Done at New York on 18 May, 1994 in three copies, each in English, French and Khmer languages, all three copies having equal force.

Sur la base des principes du respect mutuel, de l'intégrité territoriale et non-intervention dans les affaires internes de l'un l'autre, et ainsi qu'en conformité avec les normes du droit international et les dispositions de la Charte de l'Organisation des Nations Unies,


Sont convenus d'établir les relations diplomatiques conformément à la Convention de Vienne sur les relations diplomatiques en date du 18 Avril, 1961.
