**COMUNICADO CONJUNTO  
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS  
ENTRE LA REPUBLICA DE BOLIVIA

La República de Bolivia y el Reino de Cambodia, guiados por los principios del respeto mutuo, soberanía e integridad territorial, no intervención en los asuntos internos de los Estados y en concordancia con las normas del derecho internacional y la Carta de las Naciones Unidas, han decidido establecer relaciones diplomáticas a partir de la fecha de este Comunicado Conjunto, teniendo en cuenta las regulaciones de la Convención de Viena sobre Relaciones Diplomáticas de 1961.

La República de Bolivia y el Reino de Cambodia expresan su confianza en que el establecimiento de relaciones diplomáticas promoverá el desarrollo de amistosos vínculos de cooperación en los campos político, económico y cultural, entre los dos países.

Dado en Nueva York, el 26 de abril de 1994, en tres copias en los idiomas Español, Khmer e Inglés, cuyos textos son igualmente válidos.

**JOINT COMMUNIQUE  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN THE KINGDOM OF CAMBODIA  
AND  
THE REPUBLIC OF BOLIVIA**

The Kingdom of Cambodia and the Republic of Bolivia, guided by the principles of mutual respect, sovereignty and the territorial integrity, non-interference in internal affairs of the States and in accordance with the norms of the international law and the Charter of the United Nations, have decided to establish diplomatic relations as of the date of this Joint Communiqué, taking into account the regulations of the Vienna Convention on Diplomatic Relations of 1961.

The Kingdom of Cambodia and the Republic of Bolivia express their confidence that the establishment of diplomatic relations will promote the development of friendly links of cooperation in the political, economical and cultural fields, between the two countries.

Done at New York, on April 26, 1994 in three equally authentic texts in the Spanish, Khmer and English languages, whereas all three copies have equal force.
