EXCELLENCY,

WE HAVE THE HONOUR TO INFORM YOU THAT THE GOVERNMENT OF BELIZE AND THE GOVERNMENT OF THE ARAB REPUBLIC OF EGYPT IN ORDER TO PROMOTE THE RELATIONS OF FRIENDSHIP AND COOPERATION BETWEEN THE TWO COUNTRIES AND GUIDED BY THE PRINCIPLES OF INTERNATIONAL LAW AND THE CHARTER OF THE UNITED NATIONS, HAVE ESTABLISHED DIPLOMATIC RELATIONS AT THE AMBASSADORIAL LEVEL AS OF MAY 6, 1994.

IT IS AGREED THAT THE ESTABLISHMENT OF SUCH RELATIONS WILL BE THROUGH NON-RESIDENT ACCREDITATION.

WE, THEREFORE, KINDLY REQUEST YOUR EXCELLENCY'S ASSISTANCE IN CIRCULATING THE ENCLOSED JOINT COMMUNIQUE, WHICH WE HAVE SIGNED ON BEHALF OF OUR RESPECTIVE GOVERNMENTS, TO ALL MEMBER STATES OF THE UNITED NATIONS.

PLEASE ACCEPT, EXCELLENCY, THE RENEWED ASSURANCES OF OUR HIGHEST CONSIDERATION.

THE GOVERNMENT OF BELIZE AND THE GOVERNMENT OF THE  
ARAB REPUBLIC OF EGYPT, DESIROUS OF DEVELOPING THE RELATIONS OF  
FRIENDSHIP AND COOPERATION IN ALL FIELDS BETWEEN THE TWO  
COUNTRIES, HAVE AGREED TO ESTABLISH DIPLOMATIC RELATIONS AT THE  
AMBASSADORIAL LEVEL, AS FROM MAY 6, 1994, IN ACCORDANCE WITH  
THE VIENNA CONVENTION OF DIPLOMATIC RELATIONS OF 18 APRIL, 1961  
AND THE IDEALS OF INDEPENDENCE, EQUALITY, MUTUAL BENEFIT AND  
NON-INTERFERENCE IN THE INTERNAL AFFAIRS.
