

We have the honor to inform that today, February 8, 1994, the Governments of Malta and of the Republic of the Marshall Islands have established diplomatic relations.



JOINT DECLARATION


on the Establishment of Diplomatic Relations between Malta and the Republic of the Marshall Islands

Malta and the Republic of the Marshall Islands take great pleasure in announcing their mutual recognition and establishment of diplomatic relations.

It is the intention of both Governments to complete the timely appointment of Ambassadors to each others' country. This will, initially, be on a Non-Resident basis, with Resident Ambassadors being appointed as and when circumstances permit.

Both Governments look forward to the further development of close and friendly relations between them and their peoples.
