Excellency,

We have the honour to inform Your Excellency that the Governments of the Republic of Namibia and of the Czech Republic have decided to establish diplomatic relations and to that effect have signed the following Protocol:

" The Governments of the Republic of Namibia and of the Czech Republic, desirous to reinforce the relations of friendship and cooperation which exist between their two countries, and on the basis of respect for the principles of international law and for the Charter of the United Nations, have decided to establish diplomatic relations at the level of Ambassadors, on non-residential basis, with effect from 1 January 1993.

Done at New York on this Second day of March, One Thousand Nine Hundred Ninety Four (1994)."

We would appreciate if the present communication could be circulated among all the Member States of the United Nations and we take this opportunity to renew to Your Excellency the assurances of our highest consideration.
