Protocol

on the establishment of diplomatic relations
between the Republic of Kazakhstan and the
Kingdom of Cambodia

The Republic of Kazakhstan and the Kingdom of Cambodia following the mutual desire to develop friendship and cooperation in political, economic and cultural fields, on the basis of the principles of mutual respect, territorial integrity and non-interference in the internal affairs as well as in accordance with the norms of international law and principles of the Charter of the United Nations, agreed to establish diplomatic relations in accordance with the Vienna Convention on Diplomatic Relations of April 18, 1961.

The Republic of Kazakhstan and the Kingdom of Cambodia express their confidence that the establishment of diplomatic relations between them meets their national interests and will promote the development of international and regional cooperation.

Done at New York, February 25, 1994 in three copies, in Kazakh, Cambodian and English languages whereas all three copies have equal force.
