Protocol on the establishment of diplomatic relations between Ukraine and the Republic of Mozambique

Ukraine and the Republic of Mozambique guided by mutual willingness to develop relations of friendship and co-operation between them in political, trade, economic and other fields have decided to establish diplomatic relations at Ambassadorial level as of the date of signing of this Protocol.

The Two Sides have reached an agreement to develop their relations on the basis of principles of equality of states, mutual respect, self-determination, independence and sovereignty, territorial integrity and non-interference in the internal affairs of each other in accordance with the UN Charter.

Both Sides are convinced that the establishment of diplomatic relations between Ukraine and the Republic of Mozambique corresponds to the interests of the Two States and will facilitate strengthening of international co-operation and universal peace.

The Two Sides have agreed to base their diplomatic relations on the Vienna Convention on Diplomatic Relations, done on April 18, 1961, to which Ukraine and the Republic of Mozambique are both parties.

The Representatives of Ukraine and the Republic of Mozambique duly authorized have signed this Protocol in duplicate, in the Ukrainian and Portuguese languages, both texts being equally authentic.
