

JOINT DECLARATION
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE GOVERNMENT OF THE FEDERATED STATES OF MICRONESIA
AND
THE GOVERNMENT OF THE ARGENTINE REPUBLIC

Desiring to develop friendly relations and strengthen the co-operation between the two countries and their peoples, the Governments of the Federated States of Micronesia and the Argentine Republic have decided to establish diplomatic relations at ambassadorial level.

This decision is based on the desire to contribute to the strengthening of international peace and security on the basis of respect for the principles and purposes of the Charter of the United Nations and International Law.

Done in the city of New York, this 27th day of July 1993, in two originals, both equally authentic, in the Spanish and English languages.

DECLARACION CONJUNTA


