JOINT COMMUNIQUE

CONCERNING THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF AUSTRIA AND THE DEMOCRATIC REPUBLIC OF SAO TOME AND PRINCIPE

The Austrian Federal Government and the Government of the Democratic Republic of Sao Tome and Principe have agreed to establish bonds of friendship and co-operation on the basis of the principles of mutual respect of national sovereignty, territorial integrity, non-interference in the internal affairs of each other, and equal rights.

Desiring to obtain this objective, the two Governments have decided to establish diplomatic relations with effect from 3 May 1993. The Government of both countries express the hope that the establishment of diplomatic relations will lead to further improvement of the existing friendly relations and the mutually beneficial co-operation between the two countries."
