We have the honour to inform that the Republic of Guatemala and Ukraine, in order to ensure further development of friendly relations between them, to promote cooperation in areas of common interest for the benefit of the two countries, to act jointly in support of peace in the international community in accordance with the purposes and principles enshrined in the United Nations Charter and with reference to the relevant provisions of the Vienna Convention that regulate diplomatic relations between States, have decided to establish, as from January 12th 1993, diplomatic relations between them at Ambassadorial level.

We have the honour, further, to kindly request Your Excellency to have the enclosed Protocol circulated as a document of the United Nations among the Member States of the United Nations for their information.

We take this opportunity to renew to Your Excellency, the assurances of our highest consideration.

PROTOCOL

On the establishment of diplomatic relations  
between the Republic of Guatemala and Ukraine.

The Republic of Guatemala and Ukraine, desiring to develop and strengthen the relations of friendship and cooperation between them,

Have decided to establish diplomatic relations at Ambassadorial level as of the date of signature of this Protocol, in accordance with the provisions of the Vienna Convention of Diplomatic Relations dated 18 April 1961. The Republic of Guatemala and Ukraine have agreed to develop their relations on the basis of the principles enshrined in the Charter of the United Nations.

Done at New York, on January 12th, 1993 in duplicate in Spanish and Ukrainian languages, both texts being equally authentic.

PROTOCOLO  
Sobre el establecimiento de relaciones diplomáticas  
entre la República de Guatemala y Ucrania

La República de Guatemala y Ucrania, deseosas de desarrollar y fortalecer las relaciones de amistad y cooperación entre ellas,

Han decidido establecer relaciones diplomáticas a Nivel de Embajadores a partir de la fecha de la firma de este Protocolo, de conformidad con disposiciones de la convención de Viena sobre Relaciones diplomáticas del 18 de abril de 1961. La República de Guatemala y Ucrania han acordado desarrollar sus relaciones sobre la base de los principios consagrados en la Carta de las Naciones Unidas.

Hecho en Nueva York el 12 de enero de 1993 en versión doble en idiomas español y ucraniano, siendo ambos textos igualmente auténticos.
