
Your Excellency,


It was agreed that the establishment of such relations would, in the first instance, be through non-resident accreditation.

ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE KINGDOM OF SWAZILAND  
AND  
THE REPUBLIC OF GUYANA

On 26 February 1993, the Kingdom of Swaziland and the Republic of Guyana issued a Joint Communique establishing diplomatic relations between the two countries, as follows:

"JOINT COMMUNIQUE ON THE ESTABLISHMENT  
OF DIPLOMATIC RELATIONS  
BETWEEN  
THE KINGDOM OF SWAZILAND  
AND  
THE REPUBLIC OF GUYANA

The Government of the Kingdom of Swaziland and the Republic of Guyana, desirous of further strengthening their friendship and promoting co-operation between their two countries for mutual benefit have decided on the basis of the principles of sovereign equality and mutual respect for each other's independence to establish diplomatic relations at the Ambassadorial level.

It is agreed that the establishment of such relations will in the first instance, be through non-resident accreditation."

Done at NEW YORK, this twenty-sixth day of February, One Thousand Nine Hundred and Ninety-Three.
