
Excellency,



JOINT DECLARATION

*ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE RUSSIAN FEDERATION AND BARBADOS*

The Russian Federation and Barbados desirous of developing and strengthening relations between the two countries in the interests of peace and cooperation among peoples and on the basis of mutual respect for independence, sovereignty and territorial integrity, as well as on the principles of non-interference, non-use of force in international relations, peaceful settlement of disputes and other principles enshrined in the Charter of the United Nations, have agreed to establish diplomatic relations between the two countries at ambassadorial level and designate, as a first step, ambassadors on a non-resident basis.
