ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

BETWEEN

THE REPUBLIC OF MALDIVES

TURKMENISTAN


THE REPUBLIC OF MALDIVES AND TURKMENISTAN, GUIDED BY THE PRINCIPLES ENUNCIATED IN THE CHARTER OF THE UNITED NATIONS AND BEING DESIROUS TO ESTABLISH RELATIONS OF FRIENDSHIP AND MUTUALLY BENEFICIAL COOPERATION, HAVE DECIDED TO ESTABLISH DIPLOMATIC RELATIONS BETWEEN THE TWO COUNTRIES AT AMBASSADORIAL LEVEL WITH EFFECT FROM SEPTEMBER, 25 1992.
