NOTE BY THE SECRETARY-GENERAL

In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-Genera! has the honour to communicate the following legislative text.

Australia: Government of South Australia

DANGEROUS DRUGS ACT, 1934. -- APPLICATION TO SPECIFIED DRUGS

SOUTH AUSTRALIA (Proclamation by His Excellency the Governor of the to wit. (State of South Australia.

BY virtue of the provisions of the Dangerous Drugs Act, 1934, and all other enabling powers, I, the said Governor, with the advice and consent of the Executive Council, do hereby--

- 1. Vary the proclamation which was made under the said Act and published in the Government Gazette of the 22nd day of April, 1948, at page 825, by striking out the following paragraph:
 - "(a) Amidone (D1-2-dimethylamino-4: 4-diphenyl-heptane-5-one) its salts and any preparation, admixture, extract or other substance containing any proportion of methyldihydromorphinone." (1)
- 2. Declare that the said Act shall apply to the drugs specified in the schedule hereto in the same manner as it applies to the drugs mentioned in subsection (1) of section 4 of the said Act.

SCHEDULE

- Alphaprodine (L-4-Propionoxy-4-phenyl-1: 3-dimethyl-4-piperidine), its salts and any preparation, admixture, extract, or other substance containing any proportion of alphaprodine.
- Amidone (6-Dimethylamino-4: 4-diphenylheptan-3-one), its salts and any preparation, admixture, extract, or other substance containing any proportion of amidone.
- Betaprodine (4-4-Propionoxy-4-phenyl-1: 3 dimethyl-4-piperidine), its salts and any preparation, admixture, extract, or other substance containing any proportion of betaprodine.
- Hydroxypethidine (Ethyl 4-m-hydroxyphenyl-1-methylpiperidine-4-carboxylate), its salts and any preparation, admixture, extract, or other substance containing any proportion of hydroxypethidine.
- Isoamidone (6-Dimethylamino-4: 4-diphenyl-5-methylbexan-3-one), its salts and any preparation, admixture, extract, or other substance containing any proportion of isoamidone.
- Ketobemidone (4-Propionyl-4-m-hydroxyphenyl-1-methylpiperidine), its salts and any preparation, admixture, extract, or other substance containing any proportion of ketobemidone.
- Methadol (6-Dimdthylamino-4-: 4-diphenylheptan-3-ol), its salts and any preparation, admixture, extract, or other substance containing any proportion of methadol.
- Methadyl acetate (6-Dimethylamino-4: 4-diphenyl-3-heptyl acetate), its salts and any preparation, admixture, extract, or other substance containing any proportion of ketobemidone.
- Note by the Secretariat: The Secretariat was notified by note of 3 April 1952 from the Permanent Australian Mission to the United Nations that "the work methyldihydromorphinone was used in error instead of amidone at the end of the quotation of sub-paragraph (a) in paragraph 1 of the revoking clause".

Phenadoxone (6-Morpholino-4: 4-diphenylheptan-3-one) its salts and any preparation, admixture, extract, or other substance containing any proportion of phenadoxone.

SOUTH AUSTRALIA

REGULATIONS UNDER THE DANGEROUS DRUGS ACT, 1934.

At the Executive Council Office, at Adelaide, this 17th day of August, 1950.

BY virtue of the provisions of the Dangerous Drugs Act, 1934, and all other powers me thereunto enabling, I, the Lieutenant-Governor of the State of South Australia, with the advice and consent of the Executive Council, hereby make the regulations set out hereunder.

Regulations under The Dangerous Drugs Act, 1934.

The regulations made pursuant to the Dangerous Drugs Act, 1934, and published in the Government Gazette of the 23rd September, 1937, at page 797 thereof, as varied from time to time, are further varied as follows:

- 1. Paragraph (g) of the Sixth Schedule to the regulations is amended by
 - a) strinking out the figures "1934" where they occur in the first and fourth lines and inserting in lieu thereof the figures "1949";
 - (b) striking out the figures "1932" where they occur in the fifth, sixth and fourteenth lines and inserting in lieu thereof the figures "1948";
 - (c) striking out the letters and figures "B.P.1932" where they occur in the seventh line and inserting in lieu thereof the letters and figures "B.P.C.1949";
 - (d) striking out the word and figures "1914 and 1932" where they occur in the fifteenth line and inserting in lieu thereof the figures "1948".
- 2. The amendments made by these regulations shall come into operation as follows:
 - (a) The amendments made by subparagraphs (a) and (c) of the preceding

- regulation shall come into operation on telst day of July, 1950.
- (b) The amendments made by sub-paragraphs (b) and (d) of the preceeding regulation shall come into operation upon the making of these regulations.

And the Honourable the Chief Secretary is to give the necessary directions herein accordingly.
