

PROCLAMATION

By His Honour JACK KEITH MURRAY, Administrator of the Territory of Papua-New Guinea.

J. K. MURRAY.

WHEREAS by the *Customs Ordinance*, 1909-1939, of the Territory of Papua it is amongst other things provided that all goods the importation of which may be prohibited by Proclamation are prohibited imports:

AND WHEREAS it is further provided by the said Ordinance that the power of prohibiting importation of goods shall authorize prohibition subject to any specified condition or restriction:

AND WHEREAS by Section seven of the Papua-New Guinea Provisional Administration Act 1945-1946 it is provided that where, by or under any law in force in any part of the Territory of Papua-New Guinea at the date of commencement of that Act, any powers, functions or duties are conferred on, vested in, or required to be performed by, the Administrator of the Territory of Papua, those powers, functions and duties shall until otherwise provided by Ordinance be deemed to be conferred on, vested in, or required to be performed by, the Administrator appointed under that Act:

AND WHEREAS the said Ordinance was a law in force as aforesaid and it has not been otherwise provided by Ordinance:

AND WHEREAS it is now deemed expedient to prohibit, the importation of certain goods:

NOW THEREFORE I, the Administrator, in pursuance of the powers conferred upon me by the said Ordinance and all other powers me enabling, do proclaim and declare that the importation of the goods referred to in the Schedule hereto is prohibited except with the written approval of the Director of Public Health.

Given under my Hand at Port Moresby, this eighth day of July, One thousand nine hundred and forty-eight, and in the twelfth year of His Majesty's reign.
