# DANGEROUS DRUGS ORDINANCE. (Cap. 30 of the Revised Edition, 1935)

#### ORDER

In exercise of the powers conferred upon him by subsection (3) of Section 9 of the Dangerous Drugs Ordinance, the Governor hereby declares that Part III of the Ordinance shall apply to the following:-

- Alphaprodine (A-4-Propionoxy-4-phenyl-1: 3dimethyl-4-piperidine), its salts and any preparation, admixture, extract or other substance containing any proportion of alphaprodine.
- Amidone (6-Dimethylamino-4: 4-diphenylheptan-3-one), its salts and any preparation, admixture, extract or other substance containing any proportion of amidone.
- Betaprodine (B-4-Propionoxy-4-phenyl-1: 3-dimethyl-4-piperidine), its salts and any preparation, admixture, extract or other substance containing any proportion of betaprodine.
- Hydroxypethidine (Ethyl 4-m-hydroxyphenyl-1-methyliperidine-4-carboxylate), its salts and any preparation, admixture, extract or other substance containing any proportion of hidroxypethidine.
- Isoamidone (6-Dimethylamino-4: 4-diphenyl-5-methylhexan-3-one), its salts and any preparation, admixture, extract or other substance containing any proportion of isoamidone.
- Ketobemidone (4-Propionyl-4-m-hydroxyphenyl-1-methylpiperidine), its salts and any preparation, admixture, extract or other substance containing any proportion of ketobemidone.
- Methadol (6-Dimethylamino-4: 4-diphenylheptan-3-ol), its salts and any preparation, admixture, extract or other substance containing any proportion of methadol.
- Methadyl accetate (6-Dimethylamino-4: 4-diphenyl-3-heptyl acetate), its salts and any preparation, admixture, extract or other substance containing any proportion of methadyl acetate.
- Phenadoxone (6-Morpholino-4: 4-diphenylheptan-3one), its salts and any preparation, admixture, extract or other substance containing any proportion of phenadoxone.
- 2. The Order made by the Governor on the 13th day of February, 1948, is hereby revoked in so far as it relates to Amidone.
