CORRECTION SLIP NO. 181 DATED THE 17TH JUNE 1946

Chapter 21, Order 21-40, page 15.

For Sub-Order (m) of Order 40 of the said Orders, the following shall be substituted, namely:-

"The licensee shall not sell excise opium or poppy-heads -

- (i) to any person who is a member of the Armed forces of the Crown or of the Armed forces of a foreign power allied with His Majesty, when in uniform, or, when not in uniform, if the licensee knows, or has reason to believe that he is a member of any such force; or
- (ii) to any person whom the licensee knows, or has reason to believe, to be a member of the family of a person mentioned in Sub-Order (i); or
- (iii) to any person whom the licensee knows, or has reason to believe, to be a follower of any of the forces mentioned in Sub-Order (i); or
- (iv) to any person whom he knows, or has reason to believe to be a policeman, excise Officer or Railway servant on duty; or
 - (v) to any person in the custody or under the escort of the police; or
 - (vi) to any insane person or minor:

Provided that the restrictions laid in Sub-Orders (i), (ii) and (iii) of the Order shall not apply to the sale made to an Indian soldier or a member of his family or a follower of His Majesty's Indian forces, when he is absent on leave from his regiment."
