JOINT COMMUNIQUÉ ON THE  
ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN  
THE REPUBLIC OF EQUATORIAL GUINEA AND THE REPUBLIC OF  
MALDIVES

The Republic of Equatorial Guinea and the Republic of Maldives, guided by a shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries, have decided to establish diplomatic relations at the level of Ambassadors.

Both parties wish to manifest their confidence that the establishment of diplomatic relations and the exchange of Ambassadors between both countries will contribute to the development of bilateral cooperation and the consolidation of world peace.

The Republic of Equatorial Guinea and the Republic of Maldives reaffirm their will to build their bilateral relationship in accordance with the Charter of the United Nations and international law, including the principles of peaceful coexistence, equality and mutual respect for the sovereignty of each other's territory, and the non-interference in each other's internal affairs.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed the Joint Communiqué in two originals, in English and Spanish, all texts being authentic.

Done and signed in New York, on the Twenty-First (21) Day of May, Two Thousand Eighteen (2018).

## COMUNICADO CONJUNTO SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS ENTRE LA REPÚBLICA DE GUINEA ECUATORIAL Y LA REPÚBLICA DE MALDIVAS

La República de Guinea Ecuatorial y la República de Maldivas, guiados por una voluntad compartida de desarrollar y fortalecer los lazos de amistad y cooperación entre los dos países, han decidido establecer relaciones diplomáticas a nivel de Embajadores.

Ambas partes desean manifestar su confianza en que el establecimiento de relaciones diplomáticas y el intercambio de embajadores entre ambos países contribuirán al desarrollo de la cooperación bilateral y la consolidación de la paz mundial.

La República de Guinea Ecuatorial y la República de Maldivas reafirman su voluntad de forjar una relación bilateral de conformidad con la Carta de las Naciones Unidas y el derecho internacional, incluidos los principios de coexistencia pacífica, igualdad y respeto mutuo de la soberanía del territorio de cada uno, y la no interferencia en los asuntos internos de cada uno.

En fe de lo cual, los Representantes abajo firmantes, debidamente autorizados por sus respectivos Gobiernos, han firmado el Comunicado Conjunto en dos originales, en inglés y español, siendo todos los textos auténticos.
