THE SITUATION IN THE OCCUPIED TERRITORIES OF CROATIA

Letter dated 30 August 1994 from the Chargé d'affaires a.i. of the Permanent Mission of Croatia to the United Nations addressed to the Secretary-General

Upon the request of the Government of the Republic of Croatia of 27~May~1994~(A/49/142), an agenda item entitled "The situation in the occupied territories of Croatia" has been placed on the provisional agenda of the fortyninth session of the General Assembly.

As the issue at hand has been previously debated in the framework of the Security Council, in the course of several years, a number of letters have been circulated by the Republic of Croatia concerning this matter. In order to underscore the importance of the aforesaid agenda item and to acquaint the participating delegations with the matter, the Permanent Mission of Croatia has prepared a list of the previously issued documents it deems pertinent, for easier reference.

This list is hereby enclosed (see annex).
