SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF  
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE  
REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in documents S/1994/20 of 20 January 1994, S/1994/20/Add.3 of 3 February 1994, S/1994/20/Add.12 of 8 April 1994, S/1994/20/Add.14 of 21 April 1994, S/1994/20/Add.21 of 10 June 1994 and S/1994/20/Add.33 of 31 August 1994.

During the week ending 1 October 1994, the Security Council took action on the following items:

The question concerning Haiti (see S/25070/Add.24 and Corr.1, S/25070/Add.34, S/25070/Add.35, S/25070/Add.37, S/25070/Add.38, S/25070/Add.41, S/25070/Add.43, S/25070/Add.46, S/1994/20/Add.1, S/1994/20/Add.11, S/1994/20/Add.17, S/1994/20/Add.25, S/1994/20/Add.27 and S/1994/20/Add.30; see also S/22110/Add.39)

The Security Council resumed its consideration of the item at its 3429th and 3430th meetings, held on 29 September 1994, in accordance with the understanding reached in its prior consultations, having before it the letter dated 27 September 1994 from the Permanent Representative of the United States of America to the United Nations addressed to the President of the Security Council (S/1994/1107).

At the 3429th meeting, which was attended by the Minister of External Relations of the Federative Republic of Brazil, the Deputy Minister for Foreign Affairs of the Czech Republic, the Minister for Foreign Affairs of the French Republic, the Deputy Prime Minister, Minister for Foreign Affairs and Trade, of New Zealand, the Minister of State for Foreign Affairs of the Sultanate of Oman and the Secretary of State of the United States of America, the President, with the consent of the Council, invited the representative of Haiti, at his request, to participate in the discussion without the right to vote.

At the 3430th meeting, in addition to the representative of Haiti, to whom an invitation had been extended at the previous meeting, the President, with the consent of the Council, also invited the representatives of Canada and Venezuela, at their request, to participate in the discussion without the right to vote.

At the same meeting, the President drew attention to the text of a draft resolution (S/1994/1109) submitted by Argentina, Canada, France, Haiti, Spain, the United States of America and Venezuela.

The Security Council proceeded to vote on draft resolution S/1994/1109 and adopted it by 13 votes in favour to none against with 2 abstentions (Brazil and Russian Federation) as resolution 944 (1994) (for the text, see S/RES/944 (1994); to be issued in Official Records of the Security Council, Forty-ninth Year, Resolutions and decisions of the Security Council, 1994).

The Security Council resumed its consideration of the item at its 3431st meeting, held on 29 September 1994, in accordance with the understanding reached in its prior consultations, having before it the report of the Secretary-General on the United Nations Angola Verification Mission (UNAVEM II) (S/1994/1069).

The President, with the consent of the Council, invited the representative of Angola, at his request, to participate in the discussion without the right to vote.

The President drew attention to the text of a draft resolution (S/1994/1110) that had been prepared in the course of the Council's prior consultations.

The Security Council proceeded to vote on draft resolution S/1994/1110 and adopted it unanimously as resolution 945 (1994) (for the text, see S/RES/945 (1994); to be issued in Official Records of the Security Council, Forty-ninth Year, Resolutions and decisions of the Security Council, 1994).

The situation in Somalia (see S/23370/Add.11, S/23370/Add.16, S/23370/Add.30, S/23370/Add.34, S/23370/Add.48, S/25070/Add.12, S/25070/Add.23, S/25070/Add.38, S/25070/Add.43, S/25070/Add.46, S/1994/20/Add.4, S/1994/20/Add.21 and S/1994/20/Add.33; see also S/23370/Add.3)

The Security Council resumed its consideration of the item at its 3432nd meeting, held on 30 September 1994, in accordance with the understanding reached in its prior consultations, having before it the report of the Secretary-General concerning the situation in Somalia (S/1994/1068).

The President, with the consent of the Council, invited the representative of Somalia, at her request, to participate in the discussion without the right to vote.

The President drew attention to the text of a draft resolution (S/1994/1119) submitted by Rwanda and Spain. The President announced that France, Nigeria, New Zealand and the United Kingdom of Great Britain and Northern Ireland had joined the sponsors of the draft resolution (S/1994/1119).

The Security Council proceeded to vote on draft resolution S/1994/1119 and adopted it by 14 votes in favour to none against with 1 abstention (United States of America) as resolution 946 (1994) (for the text, see S/RES/946 (1994); to be issued in Official Records of the Security Council, Forty-ninth Year, Resolutions and decisions of the Security Council, 1994).

The President drew attention to the text of a draft resolution (S/1994/1120) submitted by France, Spain and the United Kingdom of Great Britain and Northern Ireland, and made oral revisions to draft resolution S/1994/1120 in its provisional form.

The Security Council proceeded to vote on draft resolution S/1994/1120, as orally revised in its provisional form, and adopted it unanimously as resolution 947 (1994) (for the text, see S/RES/947 (1994); to be issued in Official Records of the Security Council, Forty-ninth Year, Resolutions and decisions of the Security Council, 1994).
