NOTE BY THE SECRETARY-GENERAL -- The Secretary-General has the honour to communicate herewith an annual report forwarded to him in pursuance of Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946. (For the form of annual reports, see document E/NR. 1949/Form)

A. GENERAL**I LAWS AND PUBLICATIONS**

The Grand National Assembly adopted Act No. 5759 of 18 April 1951 amending articles 6, 7, 18 and 27 of Act No. 3491 of 24 June 1938, amended by Act No. 5621 of 23 March 1950. This Act governs the purchase of opium, prescribes new forms for licences and strengthens penal sanctions.

II ADMINISTRATION

1. a.-c. No changes have been made and there is nothing to add to the previous report.

2. Drug addiction: According to the hospital statistics and information received from the police departments responsible for the suppression of the illicit traffic in and improper use of narcotic drugs, the number of addicts reported amounts to 917. They obtain their supplies exclusively from illicit sources. The distribution of addicts by age, sex, occupation and drug used is as follows:

Of these addicts, none was a transient; all are residents of the country.

B. Addicts are treated in Government hospitals.

The problem of addiction has no social aspect.

C. Other information

3. The competent departments of the Ministry of Justice, the Ministry of Trade and Economy, and the Ministry of the Interior, are responsible, under the supervision of the Ministry of Health and Social Welfare, for applying the provisions of the 1936 Convention for the Suppression of the Illicit Traffic in Dangerous Drugs.

The responsibilities of the central office to be established under article 11 of the 1936 Convention are at present discharged by the Criminal Investigation Department of the Ministry of the Interior.

III CONTROL OF INTERNATIONAL TRADE

1. The system of import certificates and export authorizations has continued to work satisfactorily; no difficulty arose in that connexion during 1952.

2. No change has been made in the designation of the Ministry or authorities responsible for issuing import certificates, export authorizations, or diversion or transit certificates.

3. There has been no modification in the conditions of issue of import certificates, export authorization, or diversion or transit certificates.

4. Nothing to report regarding the return of copies of export authorizations in accordance with article 13 of the Geneva Convention of 1925.

5. No case of forged or falsified import certificates came to the knowledge of the authorities during the year.

6. No difficulty has arisen with regard to transit, trans-shipment, free ports, free zones or bonded warehouses.

7. During the year no exports were made to countries which have not adopted the system of import certificates.

8. The importation of Indian hemp into Turkey is prohibited by Act No. 2313.

IV INTERNATIONAL CO-OPERATION

1. No agreements were concluded during 1952.

2. There are no points of interest or importance to report as regards co-operation with other

Governments, and no difficulties to report in this connexion.

3. Nothing to report.

V ILLICIT TRAFFIC

1. The seizures made during 1951 were concentrated chiefly in the province of Istanbul.

A summary of the figures relating to seizures is contained in the table in paragraph 4. The main areas in which smugglers were active were the provinces of Istanbul, Gaziantep and Ankara.

2. No illicit cultivation of the opium poppy was reported during the past year. The illicit cultivation of the opium poppy is prohibited by Act No. 3491. The cultivation of Indian hemp is strictly prohibited by Act No. 2313.

3. The number of prosecutions and the quantities seized during the year are given in the annex to this report.

Professions:

The great majority of traffickers in drugs are vagrants of no occupation and persons in subordinate occupations.

Penalties imposed during the year:

Imprisonment: 215 years 2 months 15 days

Fines: 225,465 Turkish pounds, 50 piastres (US\$80,502).

Local banishment: 180 years 4 months 20 days

5. All important cases required to be communicated to the United Nations under article 23 of the 1931 Limitation Convention were so communicated in the course of the year.

6. The quantities of drugs confiscated during the year are shown in detail in the annex hereto. Prepared opium is neither manufactured nor used in Turkey.

7. No figures can be given regarding the price of drugs sold in the illicit traffic. The illicit market is small and the demand limited.

B. RAW MATERIALS

VII RAW OPIUM

1. The total area of opium poppy under cultivation is 43,045 hectares. (This area is fixed by decision of the Council of Ministers).

2. As the whole harvest is not tested, it is impossible to give an estimate in kilogrammes of the total morphine content. The total morphine content of the opium exported during the year is shown in the following table:

Statistics of production are compiled from the figures furnished by the Office of Products of the Soil, under the Ministry of Economic Affairs and Trade, which is responsible for the supervision of authorized poppy cultivation in collaboration with the Ministry of Agriculture. The approximate degree of consistence of the opium mentioned above averages 17-40 per cent.

3. According to the estimates of the Directorate General of Statistics, the total quantity of raw opium to be produced is 443,937 kilogrammes. Purchases by the Office of Products of the Soil and the amount standardized total 466,251.960 kilogrammes for the year. There has been no change in the method of standardizing raw opium used by the Office for Products of the Soil.

4. No economic or social change capable of affecting the quantities produced has occurred in the areas where poppy growing is authorized.

5. The cultivation of the opium poppy is not subject to licensing; the system used is regional. Any citizen may cultivate the poppy in the authorized areas, provided he complies with article 3 of Act No. 5759 amending article 18 of Act. No. 3491. The Office for Products of the Soil has the monopoly of foreign trade.

6. No special taxes are levied on opium in Turkey.

7. a. The opium poppy is used only for the extraction of opium and oil.

b. The straw is not used as raw material for the manufacture of alkaloids.

VIII COCA LEAF

The coca plant is not cultivated in Turkey.

IX INDIAN HEMP

In Turkey the cultivation of Indian hemp is strictly prohibited by Act No. 2313.

C. MANUFACTURED DRUGS

X INTERNAL CONTROL OF MANUFACTURED DRUGS

1. At the present time drugs are not manufactured in Turkey.

2. Licences:

No licence for the manufacture or refining of drugs was granted during 1952.

3. a. None

b. As narcotic drugs are controlled by the monopoly of the Office for Products of the Soil, licences are not granted to private persons. Persons wishing to import such drugs are required to apply to the Office for an import certificate, issued by the Ministry of Health and Social Welfare.

4. Trade and distribution:

a. As drugs are subject to the monopoly system, wholesalers are not authorized to hold stocks of narcotic drugs. Drugs required by pharmaceutical products laboratories for galenical preparations are issued by the Office subject to authorization by the Ministry of Health and Social Welfare. The preparations are entered

in special registers in which the quantity of drugs employed must be accurately stated.

b. Wholesalers may act only as agents in procuring drugs for pharmacists on whose behalf they apply for authorization to the Ministry of Health and Social Welfare; wholesalers and pharmacists are required to keep special books which are permanently available for inspection by the health authorities. Doctors, chemists, dentists and veterinary surgeons are not authorized to hold stocks and can obtain drugs only against prescription and in small quantities. Pharmacists may supply narcotic drugs only against a prescription made out by a doctor, veterinary surgeon or dentist, who is not authorized to prescribe a quantity exceeding half the maximum dose for five days.

i. The books and registers of wholesalers and retailers are always made available to the health authorities. In addition to the surprise inspections carried out by the authori-

ties in special cases, periodic checks are made.

ii. The limited quantities which pharmacists are authorized to obtain cannot be considered as stocks; no one may hold stocks.

5. Manufacture of and Trade in Diacetylmorphine

a. The manufacture of diacetylmorphine is not authorized by the Government.

b. None was imported during 1952.

D. OTHER QUESTIONS

XI CHAPTER IV OF THE HAGUE OPIUM CONVENTION OF 1912

There is no treaty between Turkey and China and no exports are made to that country.

XII PREPARED OPIUM

Opium for smoking is totally prohibited by Act No. 2313 on the control of dangerous drugs.

XIII MISCELLANEOUS

Nothing to report.
