### NOTE BY THE SECRETARY-GENERAL

In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

**Proclamation No. 16 of 1951**

TO EXTEND THE APPLICATION OF PART IV OF THE DANGEROUS DRUGS ORDINANCE, 1950, TO CERTAIN DRUGS.

IN THE NAME of His Majesty GEORGE VI, by the Grace of GOD, of Great Britain, Northern Ireland and the British Dominions beyond the Seas, King, Defender of the Faith,

HILARY BLOOD—*By His Excellency* SIR HILARY RUDOLPH ROBERT BLOOD, *Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Mauritius and its Dependencies,*

WHEREAS by Section 10 of the Dangerous Drugs Ordinance, 1950, it is enacted that if the Governor is satisfied, on representation made to him in that behalf, that any new derivative of morphine or cocaine or of any salts of morphine or cocaine or any other alkaloid of opium or any other drug of whatever kind is or is likely to be productive, if improperly used, or is capable of being converted into a substance which is, or is likely to be productive, if improperly used, of ill-effects substantially of the same character or nature as or analogous to those produced by the substances mentioned in Section 9 of the said Ordinance, the Governor may by Proclamation declare that Part IV of the said Ordinance shall apply to that new derivative or alkaloid or other drug in the same manner as it applies to the drugs mentioned in the said section 9 ;

AND WHEREAS I am satisfied, on representation made to me, that the drugs specified in the Schedule to this Proclamation are, or are likely to be productive, if improperly used, or are capable of being converted into a substance which is, or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by the substances mentioned in the said section 9 ;

NOW, THEREFORE, in pursuance of the powers conferred upon me by section 10 of the said Ordinance, I do hereby proclaim and order as follows—

1. This Proclamation may be cited as the Dangerous Drugs Ordinance (Application) Proclamation, 1951.

2. Part IV of the Dangerous Drugs Ordinance, 1950, shall apply to the drugs specified in the Schedule to this Proclamation in the same manner as the said Part IV applies to the Drugs mentioned in Section 9 of that Ordinance.

Dihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrocodeine.

Acetyldihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of acetyldihydrocodeine.

4-Propionoxy-4-phenyl-1-methyl-3-ethylpiperidine, its salts and any preparation, admixture, extract or other substance containing any proportion of 4-propionoxy-4-phenyl-1-methyl-3-ethylpiperidine.

Methorphan (3-Hydroxy-N-methylmorphinan), its salts and any preparation, admixture, extract or other substance containing any proportion of Methorphan (3-Hydroxy-N-methylmorphinan).

**THE PHARMACY ORDINANCE, 1912**

**Order made by the Governor upon the recommendation of the Director of the Medical Services under Section 36 of the Pharmacy Ordinance, 1912**

**1.** This Order may be cited as the Pharmacy (Addition to List of Poisons) Order, 1951.

**2.** Part 1 of Schedule A to the Pharmacy Ordinance, 1912, as repealed and replaced by the Schedule to Government Notice No. 33 of 1940, and as subsequently amended, is amended by the substances mentioned in the Schedule to this Order being inserted in their proper places.

Dihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrocodeine.

Acetyldihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of acetyldihydrocodeine.

4-Propionoxy-4-phenyl-1-methyl-3-ethylpiperidine, its salts and any preparation, admixture, extract or other substance containing any proportion of 4-propionoxy-4-phenyl-1-methyl-3-ethylpiperidine.

Methorphan (3-Hydroxy-N-methylmorphinan), its salts and any preparation, admixture, extract or other substance containing any proportion of Methorphan (3-Hydroxy-N-methylmorphinan).
