NOTE BY THE SECRETARY-GENERAL

The Secretary-General has the honour to communicate herewith an annual report forwarded to him in pursuance of Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946. (For the form of annual reports, see document E/NR.1949/Form)

A. GENERAL

 - 2. Drug addiction
 - 1. (a). In 1952 Austrian pharmacies received 7,424 prescriptions for narcotic drugs required to be reported to the Office for the Supervision of Narcotic Drugs by reason of the amounts prescribed, as well as 1,223 long-term prescriptions.

This total of 8,647 prescriptions was divided among 2,019 persons (991 men and 1,028 women). Of these, 16 persons (8 men, 8 women) were suffering from cancer, 4 persons (3 men, 1 woman) from tuberculosis and 15 persons (13 men, 2 women) from war injuries. In the remaining cases the principal diseases involved were not known.

- (b). It is impossible to state how many addicts satisfy their requirements through illicit channels.

- 2. A classification by age groups is not feasible because the age of the drug consumers is not known in all cases. Experience has shown that they belong for the most part to the older age groups.
- 3. Particulars of the narcotics used by the persons mentioned under 2A. 1(a) follow:

28 " opium
8 " dicodide or acedicone
8 " eucodal
14 " dilaudide
147 " heptadon
10 " pervitin

In the remaining cases the persons concerned obtained, purely temporarily, small quantities of narcotics on isolated prescriptions.

- 4. Transient addicts could not be included in the statistics.
- B. As compared with previous years, there was no change in the treatment of addicts (see Annual Report for 1948).*

During 1952, a total of 59 persons were committed to institutions for dehabituation treatment; in the case of 25 persons (18 men, 7 women) it was not their first committal.

III. CONTROL OF INTERNATIONAL TRADE

- 4. In 1952, Austria exported narcotic drugs to Egypt, Australia, Yugoslavia, and Switzerland. These countries complied with the provisions of Article 13 of the Geneva Convention of 1925.
- 5. No cases of forging of import certificates or export authorizations were discovered.
- 6. There were no difficulties with regard to transit.
- 7. In cases where individual countries did not issue import certificates because the product in question is not subject to their narcotics regulations (e.g. methadone in a number of countries), the exporting firm does not receive the export authorization except on production of a statement issued by the competent authorities of the importing country confirming that the consignee is authorized to import the products in question. In accordance with Article 13, paragraph 4, of the Geneva Convention of 1925, a copy of the export authorization is transmitted in such cases to the government of the importing country, but in no case has any communication been received from the importing countries concerning the actual importation Article 13, paragraph 5).

V. ILLICIT TRAFFIC

I. There is very little illicit traffic in narcotics in Austria; from year to year the number of cases dealt with and the quantities of narcotics confiscated are declining steadily. In view of the strict control to which all trade in narcotics is subject in Austria, the diversion of narcotic drugs from the legitimate trade into illicit channels may be considered almost impossible.

Such quantities as were nevertheless confiscated are still apparently traceable to former German Army stocks; smaller quantities were probably obtained from pharmacies by means of forged prescriptions.

No smuggling of traffic into or out of the country was observed.

3. In 1952, 47 persons were reported to the judicial authorities. This figure included 15 physicians, 1 druggist, 3 students, 4 housewives, 3 tradesmen, 4 office employees, 1 agricultural worker and 16 persons of unspecified occupations.

These persons were sentenced by the courts to terms of imprisonment ranging from nine months to two years, the latter sentence being imposed in a case which also involved other offences, and to fines ranging from 800 to 2,000 schillings (US \$45.35-\$93.38).

The Heilmittelwerke Company's licence was unrestricted.

The Sanabo Company held a licence for the manufacture of 6-dimethylamino-4, 4-diphenyl-heptanone-3.

The Anton von Waldheim firm held a licence for the experimental manufacture of dihydrocodeine bitartrate and dihydrocodeinone bitartrate.

ii. The Bertalanffy, Gerot, Sanabo and Anton von Waldheim concerns manufactured the drugs listed under i.

The Chem. Pharm. Werke des Landes Steiermark produced morphine hydrochloride for medicinal purposes from confiscated raw morphine placed at its disposal.

The Heilmittelwerke Company produced 1-methyl-4-phenylpiperidine-4-carboxylic acid-ethyl and used it for manufacturing the proprietary medicine Biphenal. It also produced morphine hydrochloride for medicinal purposes from confiscated raw morphine placed at its disposal.

- iii. The drugs were manufactured for domestic needs only. However, the Bertalanffy and Gerot firms exported small quantities of their products to Egypt, Australia, Yugoslavia and Switzerland.
