In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

THE DANGEROUS DRUGS ORDINANCE, 1951 (No. 7 OF 1951)

THE DANGEROUS DRUGS (AMENDMENT) REGULATIONS, 1952

In exercise of the powers conferred by sections 16 and 46 of the Dangerous Drugs Ordinance, 1951, the Governor in Council hereby makes the following Regulations:

- 1. These Regulations may be cited as the Dangerous Drugs (Amendment) Regulations, 1952.
- 2. Paragraph (1) of regulation 8 of the Dangerous Drugs Regulations, 1951, is amended:
 - (a) by substituting the words "Colonial Secretary" for the words "Governor in Council" appearing in classes (e), (f) and (g) thereof;
 - (b) by substituting a semi-colon for the dash appearing at the end of class (j) thereof and adding immediately after class (j) a new class (k) as follows -
 - "(k) persons, other than those referred to in classes (f) and (h) of this paragraph, who are in charge of analytical laboratories and approved by the Colonial Secretary;"; and
 - (c) by substituting a colon for the full-stop appearing at the end of the proviso thereto and adding immediately after the proviso a new proviso as follows -

"And provided further that the persons referred to in class (k) of this paragraph shall only be in possession of such drugs and in such quantities as the Director of Medical Services may from time to time permit.".

THE DANGEROUS DRUGS ORDINANCE, 1951 (No. 7 OF 1951)

THE DANGEROUS DRUGS (ALTERATION OF FIRST SCHEDULE) ORDER, 1952

In exercise of the powers conferred by section 17(3) of the Dangerous Drugs Ordinance, 1951, the Governor in Council hereby makes the following Order:

- 1. This Order may be cited as the Dangerous Drugs (Alteration of First Schedule) Order, 1952.
- 2. The First Schedule to the Dangerous Drugs Ordinance, 1951, is hereby amended by the addition at the end of paragraph 15 in Part III of the following:

 "Dihydrocodeine, Acetyldihydrocodeine, 4-Propionoxy-4 phenyl-1methyl-3-ethylpiperidine, Methorphinan (3-Hydroxy-N-methylmorphinan), and their respective salts.".
