We have the honour to inform Your Excellency that the Governments of the Republic of Namibia and of the Kingdom of Swaziland have decided to establish diplomatic relations and to that effect they have signed the following Joint Communiqué:

" the Governments of the Republic of Namibia and of the Kingdom of Swaziland, guided by the principles of the Charter of the United Nations, and desirous of promoting relations of friendship and cooperation for mutual benefit, based on the principles of international law, particularly the equality among nations, the respect for independence, national sovereignty, territorial integrity and non-interference in their respective internal affairs, have decided to establish diplomatic relations as of the ~~28th FEBRUARY~~ <sup>29th FEBRUARY</sup>..... nineteen ninety two, at the level of Ambassadors."


