Excellency,

We have the honour to inform that the Government of the Republic of Cyprus and the Government of the Republic of Guatemala, in order to ensure greater development of friendly relations between them, to promote cooperation in areas of common interest for the benefit of the two countries, to act jointly in support of peace in the international community in accordance with the purposes and principles established in the United Nations Charter and with reference to the relevant provisions of the Vienna Convention that regulate diplomatic relations between States, have decided to establish, as from December 17th 1992, diplomatic relations between them at Ambassadorial level.

We have the honour, further, to request that this information be transmitted to the Permanent Missions of Member States of the United Nations.

We take this opportunity to renew to Your Excellency, the assurances of our highest consideration.


