Excellency,

We have the honour to inform Your Excellency that the Governments of the Republic of Namibia and of the Republic of Côte d'Ivoire have decided to establish diplomatic relations and to that effect they have signed the following Protocol:


" the Governments of the Republic of Namibia and of the Republic of Côte d'Ivoire, desirous to reinforce the relations of friendship and cooperation which exist between their two countries, and on the basis of the respect of the principles of international law, the Charter of the United Nations and the Charter of the Organization of African Unity, have decided to establish diplomatic relations at the level of Ambassadors with effect from the date of signing this Protocol.

Done in New York on 03 December, 1992, in duplicate in the French and English languages, both texts being equally authentic."
